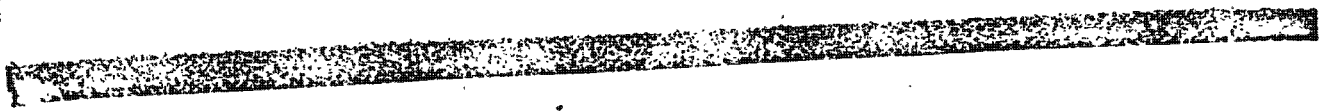

PERIS SHORT, ABOUT 5'4", BLACK HAIR, RECEDING HAIRLINE
DARK COMPLEXION. KOLETTY SAID LOOKED LEBANESE OR IRANIAN.
PLUMP, WELL GROOMED, AGE 42 BUT LOOKED OLDER, "TYPICALLY
RUSSIAN JEWISH VOICE." HE WAS BUSY BUT PROMISED TO JOIN THEM
LATER SUN-YA. ABOUT ONE HOUR LATER JOINED THEM, SPOKE
TO KANAZAWA IN RUSSIAN, KOLETTY IN ENGLISH, THEN RUSSIAN.

PERIS SAID HE BORN CONSTANTINOPLE. AGE 12 WENT TO CHITA
SIBERIA. LIVED RUSSIA 3 YEARS, THEN MOVED TO CHINA. LIVED
CHINA 18 YEARS, MOSTLY SHANGHAI AND TIENTSIN, ALSO VISITED
HARBIN. CAME JAPAN 2 YEARS EARLIER WITH 3 MONTH STOPOVER
HONG KONG. IMPORTED SUGAR INTO JAPAN AT FIRST, SUBSEQUENTLY
EXPORTING JAPANESE CARPETS TO US. AFTER DINNER PERIS TOOK
THEM "VALENCIA" CLUB SHIMBASHI. PERIS CAR 1950 PONTIAC LICENSE
J-36163. PERIS INDICATED FREQUENT VISITS VALENCIA, SEEMED KNOW
"EVERYONE" AT CLUB. TOLD KOLETTY CLUB BELONGED MANAGER LATIN
QUARTER. (ERLOTT COMMENT: SHATTUCK?) PERIS SAID DOES NOT
ASSOCIATE LOCAL WHITE RUSSIANS, DOES KNOW QUITE A FEW RUSSIAN

JEVS. WIFE DECEASED. PERIS SAID HE LIVING WITH MOTHER-IN-LAW
 WHOM HE SENDING TO STATES. SAID ALL PAPERS COMPLETE PENDING
 JAPANESE APPROVAL AND U.S. CONSULATE FORMALITIES. PERIS
 SIGNED FOR BILL., THEN TOOK THEM TO COFFEE SHOP, THEN DROPPED
 THEM WHERE KANAZAWA'S CAR PARKED. PERIS INDICATED DESIRE MEET
 KOLETTY AGAIN. KANAZAWA STATED PERIS EATS OUT EVERY NIGHT
 AND SPENDS REST OF NIGHT WITH PICKUPS. KANAZAWA ONCE LENT
 PERIS 500,000 YEN, SINCE REPAID. NO FURTHER CONTACT REPORTS.
