1. ON 8 FEBRUARY TWO LOCAL ONI INVESTIGATORS CALLED AT STATION 7 TO DISCUSS SUBJECT CASE. THEY HAD COPY OF KUBARK LETTER WITH ENCLOSURES DATED 18 NOVEMBER 1960 ADDRESSED TO NSA, ATTN MR S. WEALEY REYNOLDS.

THEY LEFT STATION ONE PAGE LIST OF QUESTIONS REGARDING GEORGE PERIS,

(initials) KOLETTY, TORONTO IS TOO LATE CLUB, GREENLAND GERMAN KITCHEN AND

DR. JACOB V. FISCHER. THEY SAID THEY DID NOT WANT TO GET INVOLVED

IN ANY OPERATIONAL INTEREST WE MAY HAVE IN ANY OF THESE PERSONS.

2. WE ADVISED THEM THAT EVERYTHING UPON PERIS, KOLETTY AND THE CLUB HAS BEEN SENT WASHINGTON AND FOR THEM TO INQUIRE AT OUR WASHINGTON HQS FOR ANY INFORMATION ON THESE IDENTITIES.

3. REGARDING THE GREENLAND GERMAN KITCHEN AND DR. FISCHER, WE ADVISED THEM THAT WE COULD NOT DISCUSS THIS PHASE WITHOUT PRIOR APPROVAL OUR HQS.

4. ACCORDING TO ONI, FISCHER OWNS THE GREENLAND GERMAN KITCHEN; HE IS A FORMER NAZI PARTY MEMBER AND HIS COMMON-LAW WIFE IS MAYARD HANAKO A JAPANESE NATIONAL. ONI ASKED FOR THE FOLLOWING INFORMATION:

- A. ANY INFORMATION ON THE RESTAURANT, FISCHER AND HAYANO.
- B. ANY INFORMATION THAT RESTAURANT WAS USED AS MEETING PLACE BY FORMER MEMBER RUSSIAN EMBASSY WHO DEFECTED TO UNITED STATES. (NAME OF THIS PERSON WAS NOT GIVEN).
- C. WAS FISCHER INVOLVED IN THIS ACTIVITY.
- D. DID DR. SORGE AND THREE OF HIS HIGH-LEVEL AGENTS MEET IN THIS RESTAURANT.
- E. DID MARTIN MEET ANY SOVIET AGENTS IN RESTAURANT.
5. NO RECORD STATION FILES ON HAYANO. ONLY RECORD OF FISCHER WAS A FILE CHECK CONDUCTED IN DECEMBER 1994. ONLY DEROG INFO DEVELOPED THEN WAS THAT HE WAS SUSPECTED OF DEALING IN BLACK MARKET.
6. FYI ONI AGENT STATED HE HAS NOT INTERVIEWED PERIS BECAUSE HE CANNOT LOCATE HIM. AGENT MENTIONED THAT HE DID NOT KNOW IF PERIS WAS IN NORTH OR SOUTH KOREA NOV.
7. WILL TAKE NO ACTION IN THIS MATTER PENDING ADVICE FROM NGB.
