U.S. CITIZEN, SUBJECT PARA 1 REF, PLEASE INFORM DEA THE FOLLOWING:

JOSEPH RAYMOND MEROLA, AN OCCASIONAL CONTACT OF OUR OVERT OFFICE IN MIAMI SINCE 1961, PERIODICALLY PROVIDES THAT OFFICE WITH FOREIGN POSITIVE INTELLIGENCE INFORMATION. IT IS SUGGESTED THAT THE FBI BE CONTACTED FOR ADDITIONAL INFORMATION. Y

2. [ ] HAS INFORMED BKHERALD JUNE 74 THAT MEROLA WAS OF OPERATIONAL INTEREST. THEY REQUESTED TRACES AND STATED HE REPORTEDLY WORKED FOR BKHERALD IN LATE 1950'S. WE REPLIED THAT MR. MEROLA HAD NEVER WORKED FOR BKHERALD, ALTHOUGH WE WERE AWARE THAT HE HAD MADE SUCH CLAIMS ON NUMBER OF PREVIOUS INSTANCES. Y

HOWEVER, EMPHASIZE TO [ ] THAT THIS FACT NOT INTENDED TO PROHIBIT THEIR USE OF SUBJECT. BATISTA WILL BE RECORDED AS A CONTACT OF [ ] IN BKHERALD FILES IN CEASE ANY OTHER U.S. GOVERNMENT AGENCY EXPRESSES OPS INTEREST. [ ] HEADQUARTERS IS BEING INFORMED OF ABOVE. Y
