1. ON 16 NOV AT CONSULATE STATION OFFICER INTERVIEWED SUBJ REF WHO ARRIVED MEXI 11 NOV FROM TOKYO VIA ALASKA AND CALIFORNIA. SUBJ SPENT SEVERAL MONTHS TOKYO. ON 6 NOV WITH AID CUBAN PRIESTS LEFT TOKYO WITHOUT ADVISING ANYONE HIS PLANS. SAME DAY RECEIVED CABLE FROM CARLOS OLIVARES ORDERING HIM GATHER EFFECTS AND RETURN HAVA. HAVN NOT OFFICALLY RESIGNED FROM POSITION.

2. SUBJ A LAWYER EXILED MEXI 1952 WHERE INTIMATE FRIEND GUSTAVO ARCOS Y BERGNES. ARCOS RECOMMENDED HIM JOB TOKYO BUT HAD FALLING OUT WITH ARCOS OVER PERSONAL AFFAIR WHILE HAVA AND RESIGNED. ATTACHE POST RECEIVED THROUGH ARCOS INTERVENTION. LATER APPROACHED PRES DORTICOS WHO LAWYER FRIEND FROM EXILE MEXI AND WAS GIVEN SAME ASSIGNMENT.

3. SUBJ REPORT ON COMMUNIST PENETRATION CUBAN EMBASSY TOKYO STARTLING. AMONG OTHER THINGS HE INVITED GO CHINA AUG 62 BY YOLANDA PEREZ WHO ATTENDED PEACE CONGRESS TOKYO THAT TIME. HAD VISA TICKETS, ETC LEAVE FOR CHINA BUT ON PRETEXT SERIOUS TOOTHACHE LAST MINUTE MISSED PLANE.

4. SUBJ REVEALS LITAMIL-1 AND LITAMIL-2 NAMES. LATTER DEBRIEFED
ON SUBJ NIGHT 15 NOV. SUBJ REVEALS BACKGROUND PER LITAMIL-2
REPORT. "CUBAN CHASER" ONLY CRITICISM SUBJ ALTHOUGH WHILE MEXI
NEVER PARTICIPATED ACTIVITIES (ASUNTOS BELICOS) HIGH LEVEL "OPERATING
GROUP" ALTHOUGH INTIMATE FRIEND ARCOS.

5. SUBJ FEARFUL MAKE CONTACT LITAMIL-2 MEXI AS LITAMIL-2 WAS
"ARDENT FIBELISTA". SUBJECT HAS MADE NO CONTACT CUBANS MEXI.
STATION PLANS "CHANCE" CONTACT LITAMIL-2.

6. VIEW SUBJ ASSIGNMENT TOKYO AND CONSEQUENT KNOWLEDGE
SITUATION THERE WHICH HE DESCRIBES AS EXTREMELY DANGEROUS MEXI
OPINION HE WORTH DEBRIEFING MIAMI OR WASH SOONEST BY FE AND WHO
OFFICERS. SUBJ NATURALLY NERVOUS PRECARIOUS POSITION HIMSELF AND
FAMILY WANTS GUIDANCE. HE DESIROUS GO MIAMI SOONEST JOIN SISTER.
ABSOLUTELY NO PUBLICITY VIEW FAMILY CUBA. LITAMIL-1 REPORT ON SUBJ,
STATION FILES AND CO'S EVALUATION ONE MEETING MEXI FAVORS ISSUANCE
VISA SOONEST FOR DEBRIEFING PEPRIME. STATION CONFIDENT AFTER TALKING
CONSUL ARRANGEMENTS CAN BE MADE LOCALLY GRANT SUBJ VISA IF STATION
