1. NAGELL LAST APPEARED AT ZURICH CONSULATE MORNING 7 MARCH AND STATED THAT IF HE RECEIVED NO SATISFACTION BY FIVE O'CLOCK THAT AFTERNOON HE WOULD CARRY OUT HIS THREATS AND EXPOSE US GOVERNMENT ON RADIO, TELEVISION AND IN THE PRESS.

2. HE THEN DISAPPEARED, NOTHING FURTHER HEARD FROM HIM AND, NO PUBLICITY GIVEN. MORNING MONDAY 10 MARCH CONSULATE ZURICH ADVISED BY TELEPHONE FROM US CONSULATE BARCELONA THAT NAGELL HAD APPROACHED THEM AND MADE SIMILAR THREATS.
