1. SUBJ, RICHARD CASE NAGELL, DPOB 5 AUG 30 NEW YORK CITY, US PASSPORT NUMBER J 543069, CAME TO CONGEN 4 JUNE, INTERVIEWED BY VICE CONSUL. TOLD INCOHERENT STORY ABOUT "WORKING FOR US GOVERNMENT SECRET AGENCY ON MISSION TO GENEVA WHERE TO MEET JAPANESE". WANTED CONGEN ASSISTANCE TO GET MONEY WHICH CLAIMS HAD DEPOSITED NEW YORK BANK BEFORE DEPARTURE US. SUBJECT WAS TOLD BY VICE CONSUL CONGEN COULD NOT ASSIST.

2. SUBJ RETURNED TO CONGEN 5 JUNE, ASKED FOR POLITICAL OFFICER, THUS WAS REFERRED TO TEGETHOFF BY RECEPTIONIST. SUBJ MADE ASSUMPTION TEGETHOFF WAS WOFIRM, WHICH DENIED. SUBJ QUITE INCOHERENT, IN FACT, APPEARS PSYCHOTIC POSSIBLY DANGEROUS. CLAIMS WAS INTERVIEWED BY NEW ORLEANS DISTRICT ATTORNEY GARRISON 14-16 MAY CN CONNECTION "CIA AND PRES KENNEDY ASSASSINATION." SUBJ CLAIMS GARRISON TOLD HIM HE IN DANGER BEING KILLED. THEREFORE WANTS "INFORM CIA HE IN ZURICH."
