KEYWAY PBRUMEN, UNRUMBLE UNBOUND

- ON 16 NOV UNRUMBLE 2 RECEIVED ORDERS REPORT UNBOUND FOR DOCUMENT CHECK. UNRUMBLE 2 INFORMED C/O UNBOUND CALL AND STATION BRIEFED UNRUMBLE 2 COOPERATE IN GENERAL FASHION WITH UNBOUND, WITHOUT REVEALING KUBARK ROLE. UNBOUND MOVE INTERPRETED BY STATION AS PLAN RECRUIT UNRUMBLE 2 FOR LOCAL CUBAN OPS.
- DURING 2 1/2 HOUR VISIT, UNRUMBLE 2 INTERVIEWED BY THREE UNBOUND OFFICIALS ABOUT HIMSELF, AND CUBAN PERSONALITIES AND ACTIVITIES PARI. DOCUMENT CHECK IGNORED BY UNBOUND. KEY PERSONALITIES OF UNBOUND INTEREST WERE UNSNAFU 1, 5 AND 9. UNRUMBLE 2 ALSO QUERIED ABOUT CUBANS LONG DEPARTED FROM FRANCE AS WELL AS ANIBAL ESCALANTE. PER STATION BRIEFING, UNRUMBLE 2 ADMITTED KNOWING MANY LOCAL CUBANS PARTICULARLY STUDENTS BUT STATED HAD LIMITED KNOWLEDGE CUBAN OFFICIALS PARI. UNRUMBLE 2 ANSWERS PRIMARILY DESIGNED PROTECT UNSNAFU 5 FROM UNBOUND INTEREST WITH STATEMENTS ACCUSING UNSNAFU 5 AS HARD CORE COMMIE DUE UNSOX POST. TO QUERY UNRUMBLE 2 LAPELED UNSNAFU 1 AS

OPPORTUNIST AND PROBABLY NOT CONFIRMED COMMIE. UNBOUND STATED THIS THEIR OPINION ALSO. UNRUMBLE 2 STATED UNSNAFU 9 PROBABLY NOT COMMIE SINCE WAS HELPED ANTI CASTRO CUBANS PARI INCLUDING UNRUMBLE 2 WITH DOCUMENTS. TO QUERY WHO WERE DANGEROUS CUBANS PARI OUTSIDE EMB UNRUMBLE 2 STATED UNSNAFU 11'S BROTHER AND POSSIBLY UNRUMBLE 5, BOTH RESIDENTS CUBA HOUSE. DURING CONVERSATION UNRUMBLE 2 TOLD UNBOUND THEY SHOULD TURN THEIR INTEREST TO UNSOX 6 AND UNRUMBLE 3 WHO OFFICIAL REPS OF ANTI CASTRO GROUPS IN FRANCE. UNRUMBLE 2 POINTED OUT HE WILLING FURNISH INFO ON STUDENTS BUT HE LIMITED SINCE ONLY A STUDENT, TIED DOWN WITH MEDICAL STUDIES, ACTIVITIES AT THE CUBA HOUSE, AND PLANS FOR DECEMBER MARRIAGE. UNRUMBLE 2 CLAIMS WAS TREATED WITH EXTREME COURTESY BY UNBOUNDERS WHO STATED WANTED TO SEE UNRUMBLE 2 AGAIN IN FUTURE, PREFERABLY OUTSIDE UNBOUND HOS. UNBOUND OFFICIALS REQUESTED UNRUMBLE 2 INFORM THEM OF ANY IMPORTANT INFO WHICH WOULD BE OF INTEREST TO CUBA AND FRANCE, POINTING OUT CUBA NOW UNBOUND TARGET OF "HIGHEST DIPLOMATIC IMPORTANCE". UNBOUND OFFICIALS ALSO STATED THEY FEAR SOMETHING WOULD OCCUR BETWEEN CUBA AND THE USA AND SOVIETS MIGHT ATTEMPT SOMETHING FROM PARIS. UNBOUND REQUESTED UNRUMBLE 2 NOT MENTION HIS VISIT TO UNBOUND TO ANYONE.

3. ON 30 NOV UNBOUND SET UP ANOTHER MEETING WHICH HELD IN LOCAL CAFE AT UNRUMBLE 2 REQUEST. UNRUMBLE 2 ALERTED C/O AND REQUESTED GUIDANCE. STATION DISCUSSED UNBOUND INTEREST UNRUMBLE 2 IN LIGHT RECENT PROPOSALS WE ENGAGE JOINT OPS AND POSSIBLE VALUE SURFACING UNRUMBLE 2 FOR JOINT OPS OR [ ] HANDLING WITH UNBOUND APPROVAL. PROBLEM DISCUSSED IN VIEW POSSIBLE UNBOUND

ATTEMPT APPROACH PROBABLY NOT PRESSURE AGAINST KUBARK BUT UNSOUND DEVELOPMENT UNRUMBLE 2 FOR CUBAN OPS PARI. STATION DECIDED CONTINUE UNILATERAL ROLE WITH UNRUMBLE 2 PENDING FURTHER DEVELOPMENTS.

4. DURING 45 MINUTE MEETING ON 30 NOV TWO UNSOUND OFFICIALS DISCUSSED UNSNAFU 4. UNRUMBLE 2 STATED HE DID NOT KNOW HIM. UNSOUND STATED UNSNAFU 4 CONTROLS EMB CIPHERS AND CABLES WHICH UNSOUND PRIORITY TARGET. UNSOUND THEN BLUNTLY STATED THEY LOOKING FOR LOCAL DEPENDABLE CUBAN TO COOPERATE WITH UNSOUND TO ATTEMPT DEFECT CUBAN DIPLOMATS. UNSOUND OFFERED UNRUMBLE 2 "ANY AMOUNT" OF MONEY FOR HIMSELF AND FOR DIPLOMATS HE COULD DEFECT IN PLACE. UNSOUND OFFER ALSO APPLIED TO UNSNAFU 11'S BROTHER.

5. BASED ON STATION BRIEFING, UNRUMBLE 2 POLITELY REFUSED UNSOUND OFFER POINTING OUT HE WILLING COOPERATE WITH THEM ON STUDENT AFFAIRS WHICH HE KNOWLEDGEABLE BUT PERSONALLY NOT INTERESTED IN ENGAGING IN INTEL ACTIVITIES OR ACCEPT MONEY WHICH AGAINST HIS PRINCIPLES AND COULD HARM FUTURE PROFESSIONAL CAREER. UNRUMBLE 2 ALSO REFUSED UNSOUND REQUEST TO INTRODUCE LOCAL CUBAN TO WORK WITH UNSOUND. UNRUMBLE 2 AGAIN REFERRED UNSOUND TO UNSOX 6 OR UNRUMBLE 3. PER STATION BRIEFING UNRUMBLE 2 BLUNTLY TOLD UNSOUND BEST POSSIBLE CONTACT MIGHT BE UNSNAFU 8 WHO IN CONTACT ALL ELEMENTS PARI BUT UNFORTUNATELY TALKS TOO MUCH. UNRUMBLE 2 CLAIMS UNSOUND STUNNED BY UNRUMBLE 2 SUGGESTION THEY USE UNSNAFU 8. (UNTROPHY REPORTED UNSNAFU 8 WORKING WITH FIS, AND UNSNAFU 8 PERSONALLY TOLD AMPAPIST 1 HE HAD OFFERED HIS SERVICES TO

WHICH ACCEPTED.)

6. DURING COURSE CAFE MEETING ANOTHER UNBOUNDER JOINED GROUP AND CONTINUED DEBRIEF UNRUMBLE 2 ABOUT LATINS IN PARI AND UNSNAFU 2. UNRUMBLE 2 STATED DID NOT KNOW WHILE NO NAMES MENTIONED. UNBOUND PROBABLY REFERRING TO UNSIGMA. UNRUMBLE 2 NEGATIVE AND VAGUE REPLIES BROUGHT MEETING TO END. IN PROCESS HOWEVER UNRUMBLE 2 BECAME AWARE UNBOUND FAIRLY WELL INFORMED CUBAN ACTIVITIES PARI INCLUDING INTIMATE AFFAIRS INSIDE EMB SUCH AS RECENT FIGHT BETWEEN AMB AND UNSNAFU 12. UNSNAFU 8 PROBABLY SOURCE THIS INFO.

7. UNBOUND THANKED UNRUMBLE 2 FOR HIS COOPERATION TO DATE, LEFT MEETING AND MADE NO PLANS FOR FUTURE CONTACT. UNRUMBLE 2 UNDER IMPRESSION HIS POLITE REFUSAL COOPERATE AND VAGUE REPLIES WILL PROBABLY CONVINCCE UNBOUND HE NOT OF INTEREST. TO DATE, UNRUMBLE 2 HAS NOT BEEN RECALLED TO UNBOUND. HQS WILL BE KEPT ADVISED OF ANY FUTURE UNBOUND UNRUMBLE 2 MEETINGS.
