


Chicago follow developments regarding Giancana's reported travel very closely and where appropriate set out immediate leads to provide appropriate coverage. In so doing, appropriate caution should be given to other offices in order to fully protect PCI Lowell Williamson as the source of information on Giancana. (u)

Legat, Paris is being alerted concerning Giancana's reported intent to visit there and possibly contact Porfirio Rubirosa. Any details concerning the date and method of travel for this proposed visit should be immediately furnished to the Bureau and appropriate offices in order that Legat, Paris and appropriate Customs officials may be alerted. (u)

No record of 27 carat uncut stone valued at \$200,000 to \$300,000 located in the National Stolen Property File. (u)

If not already done, New York promptly advise appropriate Customs officials of information furnished relative to Gennay's contact in Customs provided any indication of irregularity. (u)
