This informant advised SA JOHN W. ROBERTS, JR. on September 1, 1967, that on August 28, 1967, GUS ALEX gave an envelope full of money to GEORGE BIEBER, a Chicago attorney with offices at 188 West Randolph in Chicago. BIEBER commented to the informant that this envelope contained well over \$100,000 and that ALEX had given it to him with instructions to give it to PHIL ALDERISIO. BIEBER then contacted ALDERISIO and at 3:00 p.m. on August 28, 1967, ALDERISIO picked this envelope up from the offices of BIEBER. Neither the informant nor BIEBER knew the purpose for which this money was to be used or why it was payed.

CG 6588-C-TE advised SA ROBERTS on September 20, 1967, that on September 17, 1967, ALEX instructed Chicago hoodlum attorney BIEBER to make an arrangement so he could again enter Switzerland, it being noted that ALEX has been banned by the Swiss Government from entering Switzerland for a period of ten years. Informant advised that BIEBER thereupon contacted an unknown official, apparently in the Swiss Consulate in Chicago. ALEX, BIEBER and this official then met in BIEBER's office on September 18, 1967. At this time the official telephonically contacted another official of the Swiss Government, possibly in Washington, D.C., in this regard. The informant was unable to furnish any further details.
