He will look for updated info and call me back. Croft, Robert, Earl: Trask found an address through the Mormon Church and will provide it as well when he calls re: Bond.Dorman, Elsie, Smith: Died Sunday, 10/30/83. Trask has no address for the twosons. Mary Ferrell mentions she was survived by 2 sons: John T. Dorman, Jr., Visalia, CA, and James H. Dorman, Houston. * I am still trying to find addresses for the two sons.Hughes, Robert, J.E.: Trask believes he is dead and he doesn't have an address for the family, but feels the FBI has a good 2nd generation copy of his film.Moorman, Mary, Ann: Trask believes she is still alive but not in the Dallas area.He thinks she has remarried twice and he doesn't know the name of the most recent husband. He believes the other name she used at one time was Bartone. * I am still trying to find her.Muchmore, Marie: Trask is unsure as to Muchmore being alive or dead. He thinks UPI might have records pertaining to her film. * I am trying to find a record of her as well.Reed, Stuart, L.: Trask is unsure as to Reed being alive or dead and has no address for him.
