Description of the Call Date: 03/26/96Subject: In-Depth Interview Of Edwin Price Russo, Ph.D. Re: Estate Of His Late Brother Perry Raymond RussoSummary of the Call: I spoke with Russo today and explained the nature of the Review Board. Russo said Perry tried to distance himself over the years from the assassination and ended up dealing with it again when the movie "JFK" was being filmed. He is the executor of his brother's will and plans on handling the probate himself. He has reviewed the will and there is no mention of any files, tapes, journals, agreements, binders or anything similar. Perry Russo died with very little except for his home on Navarre street which Edwin Russo supervised the cleaning of so it could be rented. None of the articles mentioned above were found in the home. Perry accumulated a great deal of debt which Edwin is now trying to resolve. Russo said he had an estranged relationship with his brother and they really didn't speak very much even though they lived in the same city. However they did keep in touch from time to time to check up on each other. He said they were totally different since they were young and cited Perry became a cab driver and Edwin earned a Ph.D. He said they had personal differences and totally different types of friends; he did not elaborate on this statement. I asked about the identities of these friends, but he only knows nicknames of people. He apologized for not knowing more about him and that even to the day of his death, he did didn't know who the important people in Perry's life were. No other siblings exist and their parents are deceased. Russo said Perry died of a heart attack and that he had his first one about a month before he died. I asked him about the autopsy and he said: "They did one because of who he was...his whole relationship to the Garrison thing". Russo will provide a copy of Perry's death certificate as well as a copy of the autopsy once he receives some information from me on the Review Board. Russo left an open door for me to call back re: any other questions that he may help with.
