Subject: My Schedule Notes

While this is on my mind, I wanted to apprise you of a few notes on my schedule:1. As we have discussed, I probably need to go to LA before my planned trip for the Board presentation in San Diego on August 29th. Given that I need to give people advance notice and given Bob Tannenbaum's schedule (gone from LA August 12-23), I am thinking that I may have to go to LA as early as Thursday, August 8th. I would hope to:1. Check on the hearing room2. Interview Oliver Stone (I don't know what the chances of that are)3. Interview Bob Tannenbaum4. Interview David Lifton5. Interview Jim DiEugenio6. If necessary, check for alternative hearing locations.Going at the end of next week might work, particularly if people like Lifton and DiEugenio were available on Saturday for an interview.2. I need to take a day of annual leave for Friday, August 16th.3. Depending on what else needs to be done in LA for the hearing and whether or not I have already been out there, I will go to San Diego for the Board presentation either on Monday, August 26; Tuesday, August 27; or Wednesday, August 28th. If I go earlier than Wednesday, it will be because there is a reason to be in LA first. The Board presentation is on Thursday, August 29th. I will probably fly from San Diego to Boston on Friday, August 30th. 4. I will be in Nevis from Saturday, August 31 to Thursday, September 5th. At a minimum, I will be taking annual leave for Tuesday, September 3; Wednesday, September 4; and Thursday, September 5. Because I may have an appointment in Boston, it is likely that I will also need to take a day of annual leave for Friday, September 6th, as well. That would put me back in the office on Monday, September 9th. [Note: Monday, September 2 is Labor Day.]5. I will be flying back to Boston on Friday, September 13th for the weekend. Because I will want to get to LA a day before the hearing, it may be most practical for me to fly to LA from Boston on the evening of Sunday, September 15th. I am assuming I will return to DC from LA late in the day, after the hearing on Tuesday, September 17th.This may have been more than you cared to know, but it sure helped me to get it down on paper.
