 I have a pending call to Al Ortiz of CBS News, but I have not heard back from him. Thus, I plan on giving the attached letter for the CBS News President to Jack for his signature on Wednesday when he is here. This is consistent with the advice I received from Bernard Birnbaum, the veteran CBS producer who did all of the CBS assassination specials. It should have no impact on what Ortiz may do, should he come through for us. Specifically, he said that there were three departments at CBS that this matter would cut across, including: (1) Archives Department; (2) Documentaries Department; and (3) Legal Department. The issues for the legal department will be not setting a bad legal precedent for CBS regarding archival materials and copyright concerns.Ortiz will contact CBS VP Linda Mason in New York next week regarding this matter. He said that he would try to get back to me by Wednesday. Ortiz speculated that after we talked next week, we would probably want to have a conference call with Ortiz, Mason and me. If we get to that point, you, Jeremy and I should talk about who else needs to be involved, as discussion of the various issues would get more specific.Given my conversation with Ortiz, we can hold off on the letter from Jack to the CBS News President, for now. I will advise you of what Ortiz tells me next week.
