The meeting was very useful and I am confident will prove to have been an important step towards achieving our goal of completing and clairifying the record of the assassination relative to this matter. Please allow me to restate the position of the Review Board on why the additional limited testing of CE 567 is desirable and necessary. First, First, the Firearms Examination Panel of the House Select Committee on Assassinations recommended the analysis nearly 19 years ago and for unknown reasons the recommendation of the Firearms Examination Panel was deleted from the Committee's Final Report; Second, the analysis that is being discussed is limited and defined in scope. The bullet fragment and adhering fiber will be altered, but will not be destroyed in testing. Comprehensive microphotography of CE 567, prior to testing, will ensure that its present condition is documented. Documentation of the testing procedures would also become an important part of the historical record; and Third, according to the FBI, the artifact is deteriorating. The opportunity to clarify what the substance is that is adhering to CE 567 could be lost forever if it is not undertaken now. Please be assurred that The Review Board appreciates the mission of the National Archives and the concerns raised at our meeting. However, the limited testing being proposed on CE 567 is not unprecedented and, in fact, is less intrusive than what the National Archives allowed the House Select Committee on Assassinations (HSCA) to do in their testing of the ballistic evidence in the late 1970's, testing that included CE 567. As you can see from the attached excerpt from the report of Dr. Vincent Guinn, who conducted the neutron activiation analysis for the HSCA, samples had to be taken from various bullet fragments in order to conduct the tests. In a chart on page x contained in Dr. Guinn's report to the HSCA he notes that CE 567 "had a piece snipped off" and CE 399, the so-called "single bullet" that allegedly hit both President Kennedy and Governor Connolly and is perhaps the most important evidence in the case had "samples dug from the base of the bullet." In addition, CE xx had "quote from report" in order to subject a sample to neutron activiation analysis. As I know you are aware, they type of limited testing that the Review Board is requesting requires no alteration whatsover of the bullet fragment itself. According to the information that we have been provided by the FBI, the first step of the testing would require removal of the fiber from the bullet fragment. Through microscopic testing, it would be determined if the fiber is organic or man-made. what weagrreed on respective staffs working together and moving expeditiously on the following: another entityalternative testing not requiring removalidentify
