I informed him that we had released one document which identified an American (Jordan James PFUNTNER who had contacted the US Army on behalf of Alpha-66, seeking support for paramilitary and intelligence operations against Cuba. 2. Fonzi indicated that he was not familiar with the name, but that he would have to see the document to really comment on it. 3. At my prompting, he stated that he had felt stonewalled a bit by DoD and U.S. military intelligence commands during his investigation, as they did not allow access to G-2 files when requested by the HSCA.4. He again said that he would have to examine the document before commenting, but if we faxed him a copy he would run it past Antonio VECIANA and Eloy Gutierrez MENOYO to see if PFUNTNER's name rang a bell with them.5.
