SECRET DOCUMENTS RE JACK WHITE

Dear Lileen, rouay rieceived the rollowing Linan from Mary Ferren. Information in it rillid very disturbing, which I will comment on in ALL CAPS.> Dear Jack,> > Today I was trying to find a document for a researcher in England. I> finally searched the Internet in the JFK archives and, quite by accident,> ran across the name "Jack White." Then, I searched for all of the Jack> White documents and found that there are 47. The only two that I could> determine are still classified are #180-10101-10030, a 3-page letter from> Jack White to Jackie Hess and Patricia Orr. It is postponed in full. The> record indicates it is a letter and FOIA request. It is in Box 42. (I know> these documents change places, but it is now "Hit 29.) I CANNOT IMAGINE WHY THERE ARE TWO DOCUMENTS SENT BY ME TO THE HSCA WHICH ARE **POSTPONED IN FULL**. I, OF COURSE, COULD LOOK UP COPIES OF THESE PAGES IN MY FILES AND MAKE THEM PUBLIC. OF COURSE, THIS WOULD MEAN SEARCHING ABOUT 20 STORAGE BOXES OF JFK RECORDS. IT WOULD BE MUCH SIMPLER TO JUST RELEASE THE DOCUMENTS. AM I ENTITLED TO KNOW WHY DOCUMENTS I GENERATED ARE BEING WITHHELD? WHAT ARE THE OTHER 45 DOCUMENTS? AS I RECALL, THE ONLY FOIA REQUEST I EVER MADE WAS SENT TO THE JUSTICE DEPARTMENT; I MAY HAVE SENT A COPY OF IT TO HSCA STAFF (HESS/ORR). JUSTICE REJECTED MY REQUEST BECAUSE IT WAS NOT **NOTARIZED**, AND I DID NOT REFILE, I THINK. THE FOIA REQUEST WAS ABOUT MY CONCERN THAT I AND OTHER JFK RESEARCHERS WERE UNDER OBVIOUS FBI SURVEILLANCE. I LISTED 8 OR 9 OBVIOUS OCCASIONS, AND ASKED FOR REPORTS OR DOCUMENTS GENERATED. THERE CAN BE NO REASON FOR WITHHOLDING SUCH DOCUMENTS...UNLESS THERE WAS FBI SURVEILLANCE SUCH AS I WAS REPORTING...IS THERE?I THEREFORE ASK THAT THE ARRB PURSUE THIS, AND SEEK FROM THE FBI AND CIA ALL DOCUMENTS ANY AND ALL DOCUMENTS RELATING TO JACK D. WHITE OF FORT WORTH, INCLUDING SURVEILLANCE, RESEARCH, DOSSIERS, OR ANY AND ALL OTHER GOVERNMENT FILES ON ME.TWO OF THE INCIDENTS I REPORTED (ABOUT 1978?) CONCERNED MARY FERRELL. MARY HAD TOLD ME FREQUENTLY THAT SHE THOUGHT THE FBI HAD TAPPED HER PHONE, SO I ASKED FOR ANY FBI REPORTS GENERATED AS A RESULT OF ME TALKING TO MARY. THE OTHER INCIDENT OCCURRED AT MARY*S HOUSE, PROBABLY ABOUT 1976. ABOUT 2 A.M. ONE MORNING, I FINISHED SHOWING SOME SLIDES TO RESEARCHERS AT MARY*S HOUSE. WHEN MY WIFE AND I LEFT, 2 MEN IN SUITS AND HATS IN A BLACK CAR WERE PARKED ACROSS THE STREET. WHILE I WAS LOADING MY SCREEN AND PROJECTOR, THEY PULLED AWAY FROM THE CURB (NO LIGHTS), WENT DOWN THE STREET, MADE A U-TURN, AND PULLED UP BEHIND ME ABOUT 100-FEET AWAY. AS THEY DROVE BY, THEY SCRUTINIZED US CAREFULLY, MAKING NO ATTEMPT TO HIDE THEIR ACTIONS. I POINTED THEM OUT TO MY WIFE. I WANT TO KNOW WHAT REPORTS WERE GENERATED BY SUCH SURVEILLANCE, AND
