**Subject:** Weekly Report

During the previous week:I received a request from Ms. Saunders of WMAL requesting Judge Tunheim again participate in WMAL's talk show. Ms. Saunders will be calling to give us either a taping time or a time to call the studio on 4/24 to participate in the program. I worked with Craig Brownstein of C-SPAN regarding broadcast of the open board meeting on 4/24. Mr. Brownstein informs me that C-SPAN will not make a final decision until Wednesday. He is aware the meeting will be in a very small room and will last one hour or less with very little comment.I contacted Ken Herrera at AP Radio on Monday regarding an interview with Judge Tunheim on 4/24/97. Mr. Herrera informed me that they would like Judge Tunheim to call the AP studio after the 4/24/ open meeting to participate in a live, on-the-air interview regarding the decision on the Zapruder film, then AP will tape an interview with Jack for use on their hourly newscasts and for the four-minute feature broadcast. All of this may change by 4/24, but that is AP's plan.Eric and I visited NARA II on Friday to review the Rankin papers and make copies pursuant to a press release. I also picked up the "Garrison tapes" which will be the subject of a future press release.I prepared and ran through the system two press releases. One on the USSS files on Nagell and one on the FBI Appeals. At this stage, they are with Mr. Gunn. He has questions regarding the propriety of a release on Nagell, believing it may undermine some of our support among researchers. He will discuss this with Mr. Marwell. In the meantime, I have been keeping Mr. Samoluk informed on the status of all the press releases that I am currently working on.As the request of the Federal Yellow Book, I supplied Mr. Mike Finkelstein with a stock photograph of Judge Tunheim for their latest edition on important governmental figures.I discussed with Mr. Masih the pending release of Army Telecommunications message traffic. These 380 documents will be the subject of a future press release, as discussed with Mr. Samoluk.I notified interested members of the media of the 4/24 open meeting of the Review Board. Mr. Mike Dorman of Newsday asked that we call him regarding the Board decision regarding the Zapruder film as soon after the meeting as possible.I spoke with a Mr. Shannon Klewect, a member of the public, regarding what he described as a new film of the JFK assassination. I referred him to Mr. Gunn and Mr. Horne.I was out Monday caring for my ill daughter. However, I attempted to respond to my calls regarding pending ARRB business.Respectfully,Thom Wilborn
