	David:Because we may get asked some questions about the NSA documents on Tuesday, I wanted to run
	these benign talking points by you:1. The documents were identified as assassination records under the JFK
	Act by the NSA. 2. The Board review was conducted within the parameters set by the Act. 3. Consistent with
	the Act, the Board has released as much information as possible. 4. Whenever possible, if information is being
	withheld, the Board used substitute language, as provided for under the JFK Act, to make as much information
	public as possible. 5. Most of the documents are from the days following the assassination. Some are within
	months of the assassination. Several are from the mid to late 70's when the NSA was responding to various
	congressional committee requests for records related to the assassination. I know you do not us in the
	position of characterizing the documents, so if the question is asked how important are these documents or
	are these documents important, I suggest we simply say:Our job is to ensure that the JFK Collection at the
	National Archives is as complete as possible. With each addition of records to the Collection, it is more
	complete and more information is available to the American public.As far as explaining the records and what
	each of them means, we simply will not get involved in that dialogue. Please advise me of your

	additional talking points below. Please advise me of your thoughts: 1. Because of the sensitive nature of the
