Prior to working at the Review Board, Marwell served as the Director of the Berlin Document Center. He is the former Chief of Investigative Research in the Office of Special Investigations at the Department of Justice. He holds a Ph.D. in History from the State University of New York at Binghamton and a B.A. in English from Brandeis University. The Review Board has appointed Gunn as its new Executive Director. He has served as the Review Boardi¾€s Associate Director for Research and Analysis since November 1994, in addition to serving as General Counsel since January 1996. Gunn was an attorney for the Washington law firm of Covington & Burling from 1988 until he joined the Review Board staff. He is a graduate of Boston University Law School and received a Ph.D. from Harvard University. The Assassination Records Review Board was established by the JFK Act, which was signed into law by President George Bush. The five members of the Board were appointed by President Clinton, confirmed by the U.S. Senate, and sworn in on April11, 1994. The law gives the Review Board the mandate and the authority to identify, secure, and make available all records related to the assassination of President Kennedy.
