Vince: All broadcast footage by all three networks is available to anyresearcher who cares to examine it. The Museum of Broadcasting (branchesin New York and Chicago) maintains complete news archives, available forresearch (probably by prior arrangement). The only material UNavailableis outtakes from CBS specials, and probably other outtakes, though evensome of those have become available over the years. It's not clearwhether they are suppressing evidence so much as keeping "exclusive newfootage" to use in attracting audiences to future specials. Your compilation for Dealey Plaza UK includes some interestingpoints. The only thing, by the way, that was deleted from "The KennedyTapes" was duplication--otherwise, it's the complete footage for theperiod covered, and extremely valuable for including the uncut WFAA-TVfootage of a number of cameramen.Martin
