It has been claimed that Marina refuses to allow the ARRB to release these records. John Armstrong has found 3 newly released HSCA documents which give the lie to this claim and further indicate a LIE AND COVERUP BY THE HSCA AND BLAKEY. Document 1 is signed by Marina on December 2, 1978 and is titled AUTHORIZATION FOR RELEASE OF TAX RETURNS AND ATTACHMENTS, TAX RETURN INFORMATION AND INVESTIGATIVE DATA of Lee Harvey Oswald. It covers the years 1956-1963. It authorizes the IRS to release EVERYTHING. It places NO LIMIT on the release of the information. The ARRB has NO EXCUSE for withholding the records. Document 2 is signed by Marina (undated) to the National Archives enclosing a WAIVER OF RIGHTS in the release of such information. Document 3 is a transmittal letter from Howard T. Martin of the IRS dated December 19, 1978, to Blakey, which states: **ATTACHED ARE COPIES OF TAX RETURNS AND TAX INFORMATION OF LEE HARVEY OSWALD. THE MATERIAL CONSISTS OF COPIES OF INCOME TAX RETURNS FOR THE YEARS 1956, 1958, 1959 AND 1962, TOGETHER WITH A SUMMARY OF INCOME FOR THOSE YEARS, the originals of which remain in the custody of the National Archives.** (emphasis added) Apparently no IRS records exist for 1960 and 1961 (Russian period), even though as a citizen, LHO should have filed returns. Why 1957 records are not included is unexplained, although this is the Marine
