Subject: Additional Request Number 52, Dallas Local Authorities.

The Assassination Records Review Board requested access to Headquarters and Dallas field office files for liaison with the Dallas Police Department and the Sheriff's Office during the years 1960-1965.

The Historical Executive Review Unit (HERU) provided Headquarters file 62-46652, 62-53528 and 62-33925 to the Review Board staff. File 62-46652 and file 62-53528 are not believed relevant to the assassination. File 62-33925 volumes 4 and 5 were reviewed. Relevant documents in file 62-33925 have been noted. I have noted documents in file 62-33925 that have already been processed in Core files, HSCA files, or have been sent to NARA. HERU also provided Dallas file 80-741, the only Dallas file matching the additional request conditions. I recommend designating the entire Dallas 80-741 file an assassination record.
