Subject: Summary of Cuban Intelligence Activities in the U.S., Cuban Situation,
FBI Request Number 29

I have completed my review of the files the FBI produced in response to our request for additional information. Many of the files contain general information on the Cuban political, cultural, military, and economic situation and the American response to the Cuban situation that while interesting, do not provide new information on the Kennedy assassination. Most of the documents designated to be assassination documents concern anti-Castro organizations in the United States. Several documents on the procedure for disseminating information on the Cuban situation between government agencies and responses to the assassination of President Kennedy have also been designated assassination documents.

ARRB requested Headquarters, New Orleans, Miami, Tampa, New York, Washington, D.C., and Dallas files for the years 1959 through 1964, captioned Cuban Intelligence Activities in the U.S. and Cuban Situation. An additional request for files captioned Visit of President Kennedy and Possible anti-Kennedy demonstrations was submitted to the Historical and Executive Review Unit. The following files match the subject and date requirements.
