I have completed my review of the files captioned "Cuban Revolutionary Council" and "Revolutionary Democratic Council" provided by the Historical and Executive Review Unit (HERU) in response to our additional request number 30. Most of the files do not contain relevant assassination documents and several files were out of the date scope. Six documents should be designated assassination documents. ARRB should request documentation of the destruction of files 105-MM-5147 and 100A-HO-36464, documentation that Tampa has no files meeting the criteria, and continue to request Dallas file 105-1057.
