Re: Results of my review of the LBJ Library Material File No. 4.25.5

This memorandum is a catalog of the LBJ Library material I have reviewed. I was able to review fifty-six boxes of the material and part of the fifty-seventh. Listed below are summaries of the contents of each file folder, listed in order of placement within the box, and "Potential Documents of Interest" that I would have photocopied for your review had our copy account been set up. For your convenience, I have submitted a separate memorandum listing only the "Potential Documents of Interest."

To summarize, at least 75% of the material I reviewed consisted of copies of letters sent by citizens, copies of the responses to those letters, and copies of newspaper and magazine articles. Most of the government documents that did appear yielded nothing that would lead to the location or indicate the existence of other documents. Most of these government documents were internal White House memoranda circulated between various staff members.

<u>Summary</u>: Funeral plans; plans for national day of mourning; list of dignitaries attending JFK's funeral

<u>Potential Documents of Interest</u>: a) Memo from Walter Jenkins to LBJ relaying a message from Senator Humphrey which mentions a telegram received by George Meany (sender not identified) recommending that he (Meany) review "the remains." Meany felt that the rest of the Executive Committee should be sent similar telegrams.

b) A chronology of the key events in Oswald's life prepared apparently for LBJ. The entry regarding the renewal of Oswald's U.S. passport by the embassy in Moscow states that the

renewal was based on "departmental determination concurred in by INS. The department determination was that he had not effectively expatriated himself and was thus an American citizen."

<u>Summary</u>: LBJ's responses to letters and telegrams expressing condolences and best wishes; compilation of foreign reactions to the assassination and views of the foreign press as to the motivation behind it; memorandum describing LBJ's actions and moves immediately after the assassination.

- b) Telegram dated 8/12/64 from Rusk to U.S. Mission in Berlin stating that an American that may have been in a Soviet hospital with Oswald October 21-28, 1959, was being blackmailed from behind the "Iron Curtain." The man's name was Waldemar Boris Kara-patnitzky.
- c) Telegram dated 8/14/64 stating that Kara-patnitzky did not see Oswald in the Soviet hospital. Writer of the telegram states that K-p seemed concerned about Secret Service interest in him.

d) Synopsis of Oswald's military career and time in the Soviet Union. A paragraph is redacted out at the end.
