File 13, Section 1: John F. Kennedy

- 1/22/60 Report
Discusses informants' reports about the Second Session of the CPUSA of the New England District.
- 3/23/60 Memo
Discusses an informant's report on mob financing and support for Kennedy presidential campaign.
- 8/17/60 Memo
A wealthy friend of VP Nixon (name redacted) is trying to solicit contributions from wealthy individuals for the Nixon campaign; his rationale for doing so is that he believes Kennedy will turn the US into a socialist state if he is elected.
- 7/15/60 Letter
Letter from Dr. Leopold Pio Elizalde of the Cuban Institutional Defense to Kennedy discussing reasons why Kennedy should embrace anti-Castro movements.
- 11/14/60 Memo
Reports that gamblers are laying 7-to-5 odds that Kennedy will not live to be inaugurated.
- 3/27/61 Memo
"Special Purpose Automotive Equipment for the White House" memo detailing the special features of the President's new Lincoln parade car.
- 3/31/61 Memo
Discusses a letter sent to Jerry Wald of Warner Brothers Studio by an unnamed person; the

- letter contains a vitriolic attack on the whole Kennedy family.
- 4/17/61 Memo
Report states that individuals emotionally involved in the Cuban situation could threaten the President during his trip to Mayport, FL.
- 10/14/61 Memo
Kennedy's University of North Carolina speech hit strongly against extremist movements.
- 3/5/62 Teletype
During Kennedy's trip to Miami, Cuban exiles plan to demonstrate and implore the President for aid in the liberation of Cuba.
- Confidential Memo (no date)
A Florida woman (name redacted) may have connections to the CP of Albany, NY; this has something to do with Kennedy's appearance at a fund-raiser in Miami.
- 3/20/62 Memo
Contains a copy of a right-wing handbill critical of Kennedy.
- 8/17/62 Memo
 - Discusses John Roselli/Sam Giancana/Judith Campbell/John Kennedy links.
 - Agents witnessed men on Campbell's balcony attempting to break into Campbell's apartment.
 - Dallas Office furnished information about one of the subjects discussed in this memo.
- 9/14/62 Memo
Anti-Castro demonstrations planned during Kennedy's visit to Houston.
- 9/17/62 Memo
Demonstrations discussed in 9/14/62 memo did not occur.
- 9/26/62 Memo
Right-wing groups in Minneapolis plan to meet and discuss possible their plan their demonstrations against Kennedy during his trip there.
- 10/1/62 Memo
Discusses the right-wing meeting mentioned in the 9/26/62 memo.

- 11/8/63 Memo
Discusses various groups' plans for the Kennedy visit to Tampa.
 - Cuban exile informed FBI that anti-Castro Cubans have been meeting to discuss their plans to demonstrate during Kennedy's visit to Tampa
 - Informant informed FBI that the Florida KKK held a meeting to discuss their plans to picket Kennedy during his trip to the Tampa Armory.
 - Discussion of other right-wing groups' plans for Kennedy's visit.

- 11/21/63 Memo
Discusses a bundle of right-wing leaflets found in Dallas; distributor identity unknown .

- 11/18/63 Memo
Discusses KKK plans for Kennedy's visit to Tampa.

- 11/19/63 Memo
Discusses KKK plans for Kennedy's visit to Tampa.

- 11/21/63 Memo
Lists FBI informants contacted for information pertinent to Kennedy's trip to Tampa (names redacted).

- 12/21/63 Memo
Discusses an advertisement in the Tampa Tribune which contains information from Cuban exiles about Tampa-Cuba ties.

- 12/14/63 Teletype
Copy of a CIA report concerning Cuban Exile Brigade 2506's plan to demonstrate during Kennedy's visit to Miami.

- 12/16/63 Memo
Letter from Los Angeles SAC about letters sent to Robert Kennedy and President Johnson pertaining to the removal of the two children of John Kennedy who are buried at Arlington National Cemetery.

- 12/17/64 Memo
Discusses information received from congressmen about alleged CP links of persons who were to have met Kennedy during his trip to Tampa.

- 12/19/63 Letter
Letter sent by Robert Kennedy to various persons about collecting materials for the JFK Library.
- 6/2/64 Memo
Discusses author William Manchester's requests to meet with Director Hoover to discuss the Kennedy assassination.

- 12/1/63 Memo
Sets forth suggestions on how to improve presidential security.
- 12/2/63 Memo
Sets forth additional suggestions on how to improve presidential security.
- 2/20/64 Memo
Discusses an alleged Cuban exiles' planned kamikaze attack on Johnson's plane.
- 1/21/64 Memo
Discusses the alleged Cuban exile kamikaze plot and FBI efforts to substantiate the allegation.
- 2/26/64 Memorandum for Confidential Files
Discusses the investigation into the kamikaze plot and plan to protect the President's plane from such an attack (redacted).
- 7/13/65 Memo
Sets forth suggestions on how to improve presidential security (redacted).
- 11/29/63 Memo
Discusses Hoover's conversation with Johnson in which Hoover informed the President of the FBI investigation results to date.

Discusses an informant cultivated in Los Angeles.

Relates that AG Kennedy furnished the FBI information about the Los Angeles informant.
- 3/20/62 Memo

- 3/20/62 Memo
Discusses telephone calls from Judith Campbell to Evelyn Lincoln.
- 7/2/62 Report
Discusses AG Kennedy's conference with reporters during which allegations of JFK's involvement in the Profumo matter arose.
