Dear Mr. Underwood:

Thank you for agreeing to meet with us for a second time in order to take your deposition under oath. This will enable the ARRB to have on the public record the most accurate account of your story pertaining to the events surrounding the Kennedy assassination. As you are aware, the ARRB's mandate expires on September 30, 1998, and we have been anxious to establish closure on our business with you before then. We anticipate that the deposition will take only thirty minutes to an hour of your time, and would like to accommodate you in any way that will be most comfortable for you.

We would like to conduct the deposition on Thursday, June 11, and have reserved a room at the Sheraton Hotel in Towson for this purpose. We will also be arranging to have a court reporter present. I presume the Sheraton is still your preference for the meeting place, but let me know if that has changed. We would be more than happy to provide transportation for you, if that is more convenient. When you call on Monday or Tuesday next week to confirm the date, we can then set a time that best fits your schedule.

One of the attorneys on the ARRB staff, Ms. Kim Herd, will be conducting the deposition. I think you will find her to be extremely personable and understanding. The types of questions and subject matter to be covered in the deposition will be similar to what we discussed in our meeting last July. To refresh your memory and to facilitate our discussion, I have prepared a rough outline and a few talking points of the subjects that we would like to cover. Kim and I anticipate the session to be informal.

I recognize that you have been battling a number of health problems this year and sincerely appreciate your willingness to assist us. I hope you will feel some relief to have closure on this matter as well.

Best recollections of events surrounding the assassination of President Kennedy.

As an advance man for President Kennedy, what were your impressions of how the Texas trip in November 1963 was handled?

Were you involved in any of the planning for that trip?

Inconsistencies in what Seymour Hersh wrote in his book *The Dark Side of Camelot*.

Did you know Judith Campbell while you were an advance man for President Kennedy?

Other than advance work, did you have additional assignments for President Kennedy?

During your tour with the Kennedy administration, were you ever asked to accompany or observe Judith Campbell?

Were there inaccuracies or inconsistencies in what Gus Russo or Seymour Hersh reported about your knowledge of Judith Campbell during the Kennedy years?

If so, do you know how they got the information on which they based their account?

Meeting with Win Scott in Mexico City

Reason for your visit to Mexico City in 1966?

When did you first meet Win Scott? Why?

What was the source of the story that President Johnson specifically asked you to go to Mexico City to find out what you could about the assassination?

What did Win Scott tell you about his recollections of what happened in Mexico City on November 22, 1963?

Did you learn anything about allegations of Cuban involvement in the assassination?

Did you learn anything about allegations of mafia involvement in the assassination?

Handwritten notes on recollections of meeting with Win Scott.

When did you write these notes?

Do you know what happened to the originals?

What were the circumstances of your giving them to Gus Russo?

What is underneath the redacted sections? When were these redactions made?

Did you also show Gus Russo the set of typed notes you sent to David Marwell with your letter that you sent in August 1997?

Were there inconsistencies in what you stated and recollected and what was actually reported by either Gus Russo or Seymour Hersh?
