Additional questions and topics for Anne Goodpasture's follow-up deposition:

# Knowledge of Staff D operations

Did Ms. Goodpasture have the proper clearances or need to know for all of Staff D operations?

When she wrote the Mexico City History, did she have access to Staff D records or did Staff D provide any information that she included in that report?

Is it possible Staff D or Technical Services Division (TSD) conducted additional surveillance not covered in Ms. Goodpasture's History of the Mexico City Station?

## Knowledge of bugging operations and hidden microphone surveillance

To what extent were these methods of surveillance active at the time of LHO's visit in September-October 1963?

Would Anne Goodpasture have been involved in handling the take from such operations?

Does she know who had responsibility for these other operations? Was she kept in the loop?

### Marty Underwood story and Cubana Airlines passenger

Does Anne Goodpasture remember Marty Underwood, LBJ's advance man, coming to Mexico City during President's Johnson visit in April 1966?

According to Underwood, Win Scott was very bothered by the assassination and intimated that the CIA "blew it" in 1963. Did Win Scott ever share such thoughts with Ms. Goodpasture? After the assassination, did Win Scott express regrets that the CIA could have done something to prevent the tragedy?

Does Ms. Goodpasture have any recollections of any CIA surveillance at the Mexico City airport playing a role in the events surrounding the assassination?

Did Ms. Goodpasture have any role in handling take obtained from the LIFIRE operation at the airport?

Information on unidentified passenger on Cubana airlines flight?

Any knowledge of Cuban intelligence officials in Mexico City on the day of the assassination?

# CIA cooperation with FBI

Given CIA's relationship with FBI, what information did CIA share with FBI concerning LHO before the assassination?

What information did CIA share with FBI on the day of the assassination?

Did CIA inform FBI of any activities concerning suspected Cuban DGI officials traveling to or from the U.S.?

Did CIA pass on to FBI information concerning travel of Cubans between Mexico City and Dallas on the day of the assassination?

### Destruction of tapes of telephone intercepts:

At the time of the assassination, the Mexico City station no longer had the tapes of Oswald's voice.

CIA's explanation for this has been that tapes were routinely erased after two weeks. Yet a review of the cables concerning Oswald prior to the assassination, and the fact that the station reported his visit to HQ, indicate that he was not considered a routine case.

By the time of the October 10 cables (exhibits 7 & 8) which stated that LHO was probably a former defector to USSR, and then the October 15 cables (exhibit 9) requesting a photo of Oswald wasn't there enough interest in the Oswald visit to have warranted retaining the take believed to be linked to his phone call? If the take at this point was not yet two weeks old, (the phone call to the Soviet Embassy in which LHO used his name was made on October 1) then why was the "routine" procedure of erasing tapes after two weeks applied?

What prompted the October 15 request for Headquarters to pouch a photo of Oswald? This request came after the station had linked the phone call with the photographic logs. Does Ms. Goodpasture remember whether someone at the station realized the initial linking of the mystery man photo to Oswald was an error, prior to television coverage of Oswald on the day of the assassination?

If the standard operating procedures of the station was to prepare resuma of all transcripts of interest, what would have happened to those records?

When the station received instructions not to destroy tapes, what happened to the take from the two weeks prior to the assassination?

### Photographic Surveillance

On pp. 85-86 of her deposition, she states that she was not responsible for identification of Oswald at the Cuban embassy and his dealings with the Cuban embassy. Does she recollect who was responsible for those activities at the Cuban embassy?

### Silvia Duran arrests and interrogations

Recollections of Mexican DFS (Direccion Federal de Seguridad) interrogation of Silvia Duran?

Did Ms. Goodpasture read reports provided by DFS on the results of the interrogations of Ms. Duran?

## CIA's Debriefing of Sources

Did Ms. Goodpasture have any knowledge of MC Station debriefing any sources in either the Cuban or Soviet embassies in the aftermath of the assassination?

How would records or reports from such debriefings have been handled?

Would the station inform HQ the results of these debriefings?

If so, would they have been forwarded in raw format to HQ or would a separate report have been prepared?

Would such reports be transmitted as cables or through backchannels?
