Re: Identification and Review of Church Committee Records Pursuant to the
JFK Assassination Records Collection Act, 44 U.S.C. § 2107

Dear Mr. Lawrence:

I am writing to summarize our current understanding of the status of efforts by the Senate Select Committee on Intelligence (“the SSCI”) to comply with the obligations created by the JFK Assassination Records Collection Act, 44 U.S.C. § 2107 (“JFK Act”). Our particular interest pertains to identifying and releasing JFK assassination records of the Senate Select Committee to Study Governmental Operations with Respect to Intelligence Activities (“the Church Committee”) that were collected and preserved as supporting documentation for the multi-volume Church Committee Report. The JFK Act specifically emphasizes that the Church Committee files are a significant source of assassination-related records. *See* 44 U.S.C. § 3(2)(C).

As you know, we have been working with you to assure the public release of all materials of the Church Committee relating to the assassination of President Kennedy.

I would like to acknowledge the work and efforts that have been undertaken by your Committee, in cooperation with several federal agencies, in providing the National Archives and Records Administration (“NARA”) with Church Committee materials relating to President Kennedy’s assassination and making those materials available to the public. This work was described in your March 7, 1997 letter to the Review Board. We understand that there are approximately 40 archival boxes of Church Committee publicly available materials now in the JFK Assassination Records Collection (“JFK Collection”) at NARA. In addition, we would like to thank you and Mr. Wolfe for the release of certain Church Committee transcripts on an expedited basis, and we are in the process

of obtaining agency approval to release those transcripts to the public.

We wish to ensure that all relevant Church Committee records have been conscientiously surveyed and that all relevant documents have been identified and reviewed under the terms of the JFK Act. In addition to the potentially relevant Church Committee records related to domestic intelligence activities in the early 1960s, we are at this time particularly interested in ensuring that we have located all relevant supporting documentation for:

“The Investigation of the Assassination of President Kennedy: The Performance of the Intelligence Agencies” (Book V, May 1976);

“Alleged Assassination Plots Involving Foreign Leaders” (Interim Report, November 1975);
and

“Addendum to Interim Report,” (contained in Book IV, **date**).¹

There are several additional matters, however, that should be addressed in order to ensure that the SSCI fulfills its obligations under the JFK Act. Those matters are set forth below:

First, the SSCI should provide the Review Board the opportunity to determine whether the redactions contained in Church Committee assassination records are appropriate under the JFK Act.

The Church Committee records that have been forward to NARA contain redactions (or “postponements” in the terminology of the JFK Act.). The Review Board must review unredacted versions of these records and make formal determinations regarding the postponements. Therefore, we request that all redacted documents (as well as their unredacted versions) be made available to the Review Board so that it can make its formal determinations. It is our understanding that the SSCI has a collection of the redacted materials showing the redactions in highlighted form. We would like to obtain access to this collection so that the Review Board can begin its review work.

¹Throughout this letter, we will refer to Book V as the “JFK Report” and to the interim report and its addenda as the “Foreign Assassinations Reports.”

Second, the SSCI should release certain testimony cited in the Church Committee's JFK Report and the Foreign Assassinations Reports. We have identified testimony cited in the JFK Report (Book V) as well as testimony cited in the Foreign Assassination Reports that pertain to Cuban President Fidel Castro (pages 71-190), South Vietnamese President Diem (pages 217-223), and to Patrice Lumumba of the Congo (pages 13-70),² that have not yet been placed in the JFK Collection at NARA. For example, our review of materials in the JFK Collection has confirmed that numerous FBI and CIA transcripts cited in the JFK Report are not at NARA.³

Therefore, we are enclosing a master list identifying testimony, including affidavits, interviews, and transcripts, cited in these reports but not yet opened to the public. In addition, we have found references to related testimony that, although not cited in the reports, may be relevant to the assassination and should be inspected for possible release. The enclosed list is in alphabetical order by last name of witness or, where the witness name is unavailable, by job title. For each item of testimony referenced, we have attempted to identify whether it was cited in the JFK Report or the Foreign Assassinations Report. See Enclosure hereto entitled, "List of Church Committee Testimony That Has Not Been Released Under the JFK Act." The first priority must be to release the testimony that is referenced in the Church Committee's Report regarding the JFK assassination.

²Unless the SSCI has information to the contrary, we consider all testimony referenced in the JFK Report and in the Foreign Assassination Report on Cuba and Vietnam presumptively to be assassination-related. With respect to the testimony cited in the section of the Foreign Assassinations Report pertaining to Patrice Lumumba, we have identified that testimony only to the extent that the officials testifying had responsibilities outside of the African region and may reasonably have been examined regarding Cuba (*e.g.*, testimony of C. Douglas Dillon, who served under Presidents Eisenhower and Kennedy, and Robert H. Johnson, who served on the National Security Council staff under Presidents Eisenhower and Kennedy). We do not presume that these transcripts are assassination records, but believe they should be inspected to determine if there is any testimony that would enhance the historical understanding of the Kennedy assassination. We take the same position with respect to the transcripts of certain CIA officials whose testimony on special operations is cited and discussed in the Addenda to the Foreign Assassinations Report.

³The opening of these records, which are directly relevant to the Kennedy assassination, is essential to accomplishing the purposes of the JFK Act. The SSCI was asked to release this testimony under the JFK Act over two years ago -- in April 1995. See April 17, 1995 Letter from Steve Tilley of NARA to Charles Battaglia of the SSCI.

Third, the Review Board seeks to identify any other assassination records of the Church Committee or Senate Select Committee. In view of the fact that testimony relating directly to the assassination of President Kennedy has not been released, the Review Board is concerned that the SSCI's search of records has not been adequate to identify all possible assassination-related records.⁴ Accordingly, we believe that a more thorough accounting of Church Committee records is necessary to ensure full compliance with the JFK Act. Furthermore, we believe it would be beneficial for the Review Board to participate more actively in the review of Church Committee records and in the identification of records relating to the assassination.

At present, the Review Board considers itself handicapped in attempting to verify that all relevant assassination-related materials have been identified by the Senate Select Committee. The SSCI has not provided the Review Board with any of the finding aids or indices that necessarily must be available for these records. Nor has the SSCI allowed the Review Board staff to inspect the original Church Committee holdings in secured storage at the National Archives. We have not even been able to get an authoritative list of Church Committee witnesses (including witnesses who testified before the Committee, witnesses who were deposed, and witnesses who were informally interviewed). We had previously requested such a list (*see* February 26, 1997 Letter from T. Jeremy Gunn to James Wolfe).

Pursuant to 44 U.S.C. § 2107(7)(j)(C)(ii), *the Review Board therefore requests access to all finding aids and indices to Church Committee records* to assist it in inventorying adequately the original Church Committee holdings and in making certain that all assassination-related records are identified and designated for public release. Additionally, we request access to the original Church Committee

⁴We have been unable to ascertain whether there may exist other Church Committee records, not cited in the Reports or otherwise identified, that are relevant to the assassination. To date, we have relied exclusively on the review and identification of assassination records by the SSCI. But, as we have demonstrated, major categories of records directly relating to the assassination have not been identified and released by the SSCI. For this reason, the Review Board wants to make certain that all major categories of Church Committee records have been adequately inventoried for assassination materials. For example, it is our understanding that there is Church Committee testimony maintained on microfilm; that there are executive session hearings of the Church Committee not in the JFK Collection; and that there may be additional records relating to the assassination generated by the SSCI after publication of the Church Committee reports. We also believe there may be testimony and records relating to the Church Committee's Report on domestic surveillance (Books II and III) that are relevant to the assassination.

Finally, we request that the person(s) most knowledgeable about the Church Committee records and the search of those records under the JFK Act be made available to us to answer any questions we may have regarding the existence, identity, or location of the original Church Committee files.

To the extent that you would like to discuss any of these matters, we would be pleased to visit you in your offices or to discuss them by phone. Again, we appreciate your continued cooperation in our efforts to ensure that the goals of the JFK Act be fulfilled.

--**Boggs, Marion** (NSC Deputy Executive Secretary), 10/10/75 affidavit (cited in Foreign Assassinations Report on Congo).

⁵We have identified this testimony through a combination of reviewing the Church Committee reports, inventorying in August the Church Committee records currently in the JFK Collection at the National Archives, utilizing NARA's index to Church Committee records in the JFK Collection, and noting testimony referenced in certain Church Committee records at the National Archives. If any of the testimony we have identified has been released to the public previously in another context (*e.g.*, under FOIA), please advise us. This list represents what we could identify to date, and it should not be construed as relieving the SSCI of identifying and releasing any other testimony or records that may relate to the assassination of President Kennedy.

--**Sullivan, William** (FBI Assistant Director for the Domestic Intelligence Division), 4/21/75 interview, 9/16/75 testimony, 4/21/76 interview (all cited in JFK Report but not released).

--**Szulg, Tad** (*The New York Times*), 6/10/75 testimony (NARA). While this testimony is in the JFK Collection at NARA, there were major redactions of this testimony, and we wish to inspect the entire transcript.

--**Trafficante, Jr., Santo**. It is our understanding that Mr. Trafficante may have testified before the Senate Select Committee on Intelligence on 10/1/76, but that this testimony has not been released.

--**Wannall, Raymond** (FBI Chief of the Nationalities Intelligence Section from 1962 to 1965).⁶ It is our understanding that Mr. Wannall testified in executive session on 10/21/75, in open session on 10/24/75, in open session on 11/19/75, in open session on 12/2/75, and in executive session on 1/21/76, but that this testimony has not been released.

--**Willens, Howard** (Assistant Counsel for the Warren Commission), 5/12/76 interview (cited in JFK Report but not released)
