Dear Mr. Secretary:

I am writing to obtain information regarding the Department of Treasury's compliance with the The President John F. Kennedy Assassination Records Collection Act ("the JFK Act"). ¹

The JFK Act required all agencies of the federal government to deliver to the National Archives, by August, 1993, all agency records related to President Kennedy's assassination. Our information shows, however, Department of Treasury has delivered *no* records to the Archives.²

Although we are not in a position to know with certainty what records Treasury has, it would be unlikely if it had no records relating to the assassination inasmuch as the the Secret Service, the Bureau of Alcohol, Tobacco, and Firearms, the Internal Review Service, and the U.S. Customs Service, all report to the Secretary. Furthermore, it would seem unlikely that Treasury had no records related to the Warren Commission, the House Select Committee on Assassinations, or to former Secretary of the Treasury John Connolly's request, while serving as Secretary, to examine all

In order to ensure that Treasury complies with the JFK Act, I would very much appreciate your designating a responsible official at Treasury who will have your authority to conduct a comprehensive search for all assassination records and who will be able to provide liaison with our office. I am enclosing a form for your designee to send to our office.

I would like to thank you in advance for your attention to this matter.
