

Pentagon Telecommunications documents

This collection of 392 documents from the Army Staff Communications Division will be complete once the following has been done:

1) Four CIA documents which have minor redactions. I have already put three of them through review track and forwarded them to you. The last document 197-10002-10196 which needs to go through review track will require the CIA team to give its final analysis on the two redactions contained in this document.

2) There are seventeen documents which have been referred to the DIA. Three of them originate from the DIA and a fourth one is a Joint Staff Document which has been stamped "requires concurrence of DIA." The remaining thirteen consist of ten Airforce attache documents and two airforce analytical documents. The thirteenth document is an Army attache document. You have the original document which lists all of the RIF numbers, signed by Anne Winner and myself at our DIA meeting.

PTC microfilm at Suitland.

All of the PTC microfilm was returned to the Federal Records Center at Suitland on May 16. You have the hand receipt for this transaction.

The IRR referral program

In December 1996 Tim, Dave and I went to IRR and met with Elaine Rogic for the first time. At this meeting proposed to Ms. Rogic, the Chief at IRR, that they copy all of the referred documents out of the HSCA segregated collection. The ARRB would take possession of these documents and then follow-up on the IRR's previous referrals to the various agencies holding equities in these documents. The overwhelming majority of these files contain FBI equities and some CIA equities. However, there are equities with other agencies for example, OSI and DAIG.

IRR agreed in late December to make the copies of the dossiers. However, it was not until mid-March that we began receiving the batches of Dossiers. Altogether there are a total of 34 dossiers, and the copies which we received only include the referred pages. There are two exceptions to the above: the Richard Case Nagell file and Antonio Veciana. They have been copied in their entirety.

All of the Dossiers are currently in the SCIF. We have only followed-up on one referral the *Richard Case Nagell* file. I have a separate folder on the portion of that file which has been sent to the DAIG, which is the majority of this dossier. Another large portion of the Nagell file has been referred to and completed by the FBI. They have agreed to release in full on all of the referred pages on Nagell.

These documents need to be sent to IRR so that they can update their data base.

Other IRR issues

There are some manuals for the 316 INTC and military Intelligence and Counterintelligence which have been sent to Elaine Rogic for declassification. If you feel the need to have more documents released by the Army just call her and push on declassifying these documents. The letter which memorializes this transaction is dated February 5, 1997. I will give this letter to you with the CSF/IRR file.

Clemard Joseph Charles File

This file originated from IRR's RODCA files (Overseas sources), and since our initial review in December 1996, it has now been thoroughly reviewed by ARRB military team staff and is now be RIF'd by Bert Haggett at the Office of the Deputy Chief of Staff for Intelligence. The Clemard file is attached to this document.

DIA

You were at the May 14 meeting with Chris and I and so you are up to speed on DIA. I have also given copies to you of all of my call reports etc. I will turn over my DIA file, although I am sure you already have copies of its contents.

Status of Ballistics projects

The status report is complete and is in Jeremy's office along with the appropriate attachments. The remaining documentation on this project is in three red wells which I have placed on one of the chairs in his office.
