- Marine Corps communication, unclassified, but referred to State Dept on 4 Sept 59. State Dept. Copy can be found in NARA Record # 119-10004-10095--Status unclassified but referred 9/24/93. P.D. Scott believes that ARRB needs to get Marine Corps version released.
- Marine HQ message 281745Z of 28 Apr 1958(19 WH 724). This record may have information on Marine HQ knowledge about Oswald's court martial conviction.
- ONI-60 letter from William Abbott, Navy Counter Intelligence, Office of CNO, to William Boswell, Dir., office of Security at State Department, forwarding Vacek's (Marine G-2) request of 3/8/60; 26 WH 46; cf. Memo of 3/23/62, 26 WH 45, regarding Oswald's renunciation of citizenship.
- ONI-122, letter of 4 Feb 1960, transmitting the ONI confidential case history on Oswald. Page 9, Footnote 48.
