FILES FROM ORIGINAL (March 1995) FBI LIST NOT INCLUDED IN JERRIE'S DATABASE

- --LuAnn Wilkins offered the following reasons for why the FBI did not include these files in its list of HSCA files we received in the summer of 1996.
- 1. Because FBI may not have found proper identification of requested (by HSCA) individual names [JZ Note: A number of these names are spelled differently on the two lists provided to us by the FBI. It is possible that the had more than one spelling for an individual's name but created a file under only one-possibly the misspelled--name.]
 - 2. Possibly FBI did not provide the file because it was not required to do so by its memorandum of understanding with HSCA
 - 3. Possibly a third agency document
 - 4. Possibly an informant file
- -- The following is a preliminary list. Some of the names require more detailed identification, which I am in the process of seeking.

Ayers, Col. Bradley E: CIA; briefed on Cuban raids by friend of JFK, Gen. Victor Krulak; learned that Roselli was involved with team of marksmen in Miami training to kill Castro (JM/WAVE) [high priority]

Bagley, Tennent: CIA Deputy Chief of Soviet Bloc [medium priority]

Bandoni, Edward J: (PFC) at Keesler Field, Biloxi, Mississippi with Oswald [low priority]

Bannister, W Guy: Gaudet said he saw Oswald talking to Bannister on the street; regular FBI contact of Sergio Arcacha Smith; Bannister's reports went to Warren DeBrueys [high priority]

Bates, Pauline: public stenographer who typed LHO's notes about Russia after he returned in June 1962 [low priority]

Beaubeouf, Alvin Roland: pro-Castro activities [associated with Ferrie?][medium priority]

Bishop, Maurice: met with Veciana, who once saw Bishop talking with LHO in Dallas (August 1963); directed Veciana to organize Alpha 66 [highest priority]

Bowen, Jack: aka John Caesar Grossi; worked in camera dept. of Jaggars-Stovall; Oswald used Bowen's name as a reference to get a public library card [low priority]

Boyd, Elmer: DPD Det.present during interrogations of Oswald; quoted Oswald saying that Hosty had accosted his wife; Boyd took gun cartridges from Oswald after Oswald's arrest [high priority]

Brereton, James N: one of six Marines (including Oswald) who traveled to Keesler Field, Biloxi,

MS from Air Technical Center, Jacksonville, FL [medium priority]

Brown, Mrs G. Stanley Brown (Vera): employee at State Department who contacted Oswald in Russia [low priority]

Brown, Morgan Holbert: associated with Jim Braden/Brading 11-21-63 at Cabana Motel; supposed to look at an oil drilling deal with Braden; knew H.L.

Hunt[medium priority]

Bruneaux, Emile: personal friend of the Murrets; obtained LHO's release from jail on 8- 10-63; PDS (page 83) Bruneau initiated Oswald's release which meant to PDS that Oswald was not a loner but was playing a pro-Castro role for a hidden political agenda; PDS considers Blakey's theory that Oswald was being tracked by anti-Castro organized crime, not controlled by organized crime. Bruneau was no leftist [PDS: highest priority]

Mather, Carl DL: former neighbor of Tippitt; his car was outside Tippitt's home on 11employed at Collins Radio Co [low priority]

McCurley, A.D.: Deputy Sherriff standing at Sherriff's door; witnessed assassination [low priority]

McLaney, William: American gambler in Havanna, forced out after Castro took over; owned property in Lacomb, LA where FBI raided 7-31-63. [high priority]

McLendon, Gordon: owner of Dallas radio station; wife's name appeared on envelope in Ruby's possessions; knew Clint Murchison; met Hoover at LaJolla; knew Ruby; knew Lamar Hunt; according to PDS, went on a clandestine trip to Mexico City in the fall of 1963. [highest priority]

Miler, Newton: Chief of Operations of Angleton's counterintelligence staff, CIA; HSCA requested his file for 1964-1975 period [medium priority]

Miller, Dusty: Sec-Treas of Teamsters Union; Ruby called him in Miami 11-8-63; PDS: visited Walter Sheridan, head of RFK's "get Hoffa" group at the Justice Dept. On Nov. 7, 1963 to find out about Parton. [high priority]

Miranda, Mike: mafia associate of Gambino and Trafficante [medium priority]

Polizzi, Alfred:not in MF or PDS or databases

Pollock-Ray Co. DL: not in databases or PDS

Porter, Marina Oswald: [high priority]

Potts, Walter Eugene: DPD Det; with William Alexander searched LHO's room on Beckley St. and found shirt [low priority]

Powers, Daniel Patrick:met LHO in Marine Aviation Detachment in Florida; played chess with LHO on ship to Atsugi [low priority]

Premindex Corp.: not in PDS or databases

Questions Re Defectors: [high priority]

Questions and Docs RE LHO: [highest priority]

Ragano, Frank:lawyer for Hoffa; knew Trafficante [high priority]

Reid, Mrs Robert A: clerical supervisor at TSBD who saw LHO with coke in his hand priority] [low

Roberts, Carson: Marine General in charge of Kaneoke Hawaii area; would have known if he had been asked to fly CID investigators looking into LHO's background. Said flight logs for his plane would be in Marine Operations. [medium priority]

Robertsreid, Earline: aka Earline Roberts but FBI might have file under this name [medium

priority]

Robinson, Col. William "Rip": PDS identifies a William "Rip" Robertson associated with but fired from CIA who associated with Somoza and was involved in Bayo-Pawley-Martino mission, Bay of Pigs; associated with Rosselli, a mystery man. [highest priority]

Robinson, Basel: If it's (Basil?): DPD a good friend of Tippitt's; assigned to Oak Cliff section [low priority]

Rogers, Sam: manager of Dobbs House on Beckley Street; believed that LHO frequented Dobbs House [low priority]

Rojas, Rolando Masferrer: (probably Masferrer but FBI might have file under this unpopular member of Batista regime. Senator in Cuba [high priority]

Romack, James Elbert:standing at NE corner of TSBD; disputed James Worrell's story of leaving rear of TSBD; witnessed assassination [low priority]

Roussel, Henry, Jr.: Marines in Santa Anna; his aunt dated LHO [low priority]

Russell, Douglas Matthews: Member of DeLois Green Gang; knew Jack Ruby; employed at Redman's Club in Dallas [high priority]

Ryan, Mickey: Dallas bartender who met Ruby in 1962 [low priority] Samuell, Ramon Font: in CIA segregated collection

Savaadra, Henry: Was in Cuba when Trafficante was hiding out there. John Hornbeck (180-10105-10404: 014468) said Macho Gener might have more information; Hornbeck said Savaadra's nickname may have been "Kiki," a name mentioned by Trafficante. [high priority]

Scibor, Mitchell J: Office manager at Klein's Sporting Goods [low priority]

Sellers Co: MF: Gary Taylor worked for Sellers Co from Sept 1963 to 1964; significance not clear

Shelley, William: Foreman at TSBD who possibly handled cartons on the sixth floor; witnessed assassination [low priority]

Shulman, Theodore: not in any databases or PDS

Sibert and O'Neill Memo re Autop: [highest priority]

Skull Fragment: [highest priority]

Slatin, Joe: Partner with Ruby in Sovereign Club in 1959; owned New Orleans Room in Dallas in 1963; had a "breakdown" after the assassination. Slatin observed that since Ruby referred to men younger than himself as "punks," Slatin doubted that Ruby would have had much to do with Oswald. [medium priority]

Slatin, Joseph: same as above?

Smith, L.C.: Dallas County Deputy Sherriff; witnessed assassination [low priority]

Sullivan, Daniel F: Continental Oil Co.geologist: attended Declan Ford's party Dec. 1963.[low priority]

Tannenbaum, Harold: operator of "French Opera House" in New Orleans; stayed in Holiday Inn in Dallas so Harold could see Ruby about being a manager of one of his clubs; spoke to Ruby several times about hiring "talent" in 1963 [medium priority]

Temple Ford Bowley: Bowley is the last name; MF:doorman at Vegas Club; wife worked as barmaid at Vegas Club; Bowley did not see Tippitt shooting but was driving past the scene after the shooting and used Tippitt's car radio to alert police of the incident [medium priority]

The Militant: weekly paper of Socialist Workers Party; WC wanted to determine if LHO ctober 14, 1963 issue [low priority]

Timphony, Frank: not in any databases or PDS

Todd, Robert James: MF: James Robert Todd?;President of Todd Oil Co in Dallas; underworld character associated with DeLois Gang; hung out at Sue's Used Car Lot with Ruby

Todd, James Robert: close friend of De Lois Green, who was killed outside Joe Bonds' club in 1949; worked at Sue's Used Car lot; knew Ruby only casually; knew R.D. Matthews and knew others in criminal element in Dallas [high priority]

Truly, Roy Sanson: superintendent of TSBD; aided Lt. John Carl Day [low priority]

Turmani, Sam: aka Turmine or Termini; friend of Marguerite Oswald in New Orleans in late 1960s; Turmani was a chauffeur for Marcello at the same time he was a Louisiana State Policeman [high priority]

Valencia, Pedro Gutierrez: US informant at CubanConsulate in Mexico City 1963; saw two men on 10-2-63; said one was Ernie; wrote to LBJ 12-2-63 [high priority]

Voebel, Edward: said he and LHO were in Ferrie's CAP group; New Orleans Police; classmate at Beauregard High School [medium priority]

Waller, Allan: friend of Martial Murret in NO (cousin of LHO) [low priority]

Wiggins, Woodrow: Lt in DPD in basement on 11-24-63; and in charge of LHO cell and security for LHO while in his cell; worked vice squad, knew Ruby [high priority]

Wilkins, George: not in any databases or PDS

Wm. Walter Allegation: [highest priority]

Zelon, Sam "Monk": not in any databases or PDS
