## Subject: Assassination Records in the files of J. Lee Rankin and Norman Redlich Follow up to FBI-37

Sydney Ready has completed his review of section one of the "security of government employees" file on Norman Redlich (FBI number 140-29239). (The Bureau is already processing sections two and three under the JFK Act.) He has also completed his review of two sections from two files regarding J. Lee Rankin (FBI numbers 77-55004 and 62-99359).

In the Redlich file, six documents in section 1 appear to be assassination records. Of these six, three appear to be duplicates of documents that have been processed in other JFK core subject files, number 62-109090 and/or 62-109060. It appears that the remaining three documents have not yet been processed under the JFK Act. We would like for the FBI to review these records to determine whether the Bureau will agree that they are assassination records eligible for processing under the JFK Act.

Of these six, four appear to be duplicates of documents that have been processed in 62-109090. It appears that the remaining two documents have not yet been processed under the JFK Act. We would like for the FBI to review these records to determine whether the Bureau will agree that they are assassination records eligible for processing under the JFK Act.
