## **NOTES**

- i. The FBI and the Review Board agree that we will finish our "negotiations" on 1/10 of the total pages left to be negotiated as of October 31, 1997. As of October 31, 1997, approximately 190,000 unprocessed pages remain to be processed and negotiated, as well as 87,624 pages of records that have been previously processed that need to be negotiated. Thus, each month, we will agree to negotiate 19,000 unprocessed pages and 8,800 previously processed pages. Pursuant to the provisions of the JFK Act, the FBI will have 30 days after the Review Board votes on a particular record (presumably at the next Review Board meeting that occurs after the negotiation of a record) to complete its "post-production" and transfer the records to the JFK Collection at NARA.
- ii. The FBI and the Review Board agree that, prior to a record being categorized as "ready for negoatiation," the FBI will re-review the record to ensure that it has only redacted information as exempt from the JFK Act where the information is, in fact, exempt. The three primary categories of information that the FBI would claim as exempt from the JFK Act are (1) information under seal of a court (e.g. grand jury information) and (2) tax return information as defined by § 6103 of the Internal Revenue Code.
- iii. The FBI and the Review Board agree that "closing out" a request for additional information will involve at least the following steps:
  - (1) the FBI will ensure that all requested records have been provided to the Review Board or, if the requested records were not provided, the FBI will explain in writing to the Review Board why the records were not provided (e.g. the records did not exist or were destroyed);
  - (2) the Review Board staff will ensure that it has reviewed all records provided and that it has provided the FBI with a written list of any assassination records the Review Board staff finds in the files;
  - (3) the FBI will ensure that it has reviewed any assassination records located by Review Board staff and provided to the Review Board evidence to support any postponements that it believes are applicable to the records:
  - (4) where necessary, the Review Board staff will ensure that the Review Board has had an opportunity to consider and vote on any outstanding issues in the requested records at the Review Board's next scheduled meeting; and
  - (5) the FBI will prepare for transfer to the Archivist any assassination records in the requested materials.
