Subject: HSCA Subjects "in progress"

We have approximately 30 HSCA subjects that I have categorized as "in progress," which is to say that a member of the FBI team has started negotiating the subject, but has not finished his or her negotiation. Some subjects are "in progress" because you are currently working on the file. Other subjects are "in progress" because one of the sections is "on locate" at the FBI. Still other subjects are "in progress" simply because the FBI team member moved on to a different file before he or she completed negotiating every volume of the file on which he or she was working. Finally, the FBI team may have actually completed negotiation of a file that I have listed as "in progress" but my records may not yet reflect that the subject is complete.

In order to shepherd these subjects on to post-production (and thus to the National Archives), I have created a list for each FBI team member listing his or her subjects that are "in progress." The lists identify which sections within a subject are complete and which sections still need to be completed. Please review your list and update me on the status of your outstanding subjects "in progress."
