Subject:	Metropolitan Crime Commission Records in New Orleans	Copying

This memo documents my August, 1996 activities with regard to review and copying of the New Orleans Metropolitan Crime Commission records.

## Records in Records Management and Protection, Inc. Warehouse

On August 12, 1996, I went to the Records Management and Protection, Inc. warehouse (the warehouse), to oversee the copying of those records that Phil, Kevin, and I identified in our June trip to New Orleans. As we previously arranged, the warehouse had hired a temporary employee to work on the copying. The "temp" was slower than we had hoped, and although she began to copy the records that morning, she had not yet finished two full boxes (numbers 81 and 82) of Guy Banister files by the next Wednesday (August 21.) Rather than have her finish the remaining two boxes, I first discussed the issue with Tony Radosti at the MCC, and then we arranged to have CBD Docusource pick up the two boxes from the warehouse and copy them. Tony said that when CBD Docusource finishes copying the two Banister boxes AND the eight Warren DeBrueys boxes, they should return <u>all</u> of the MCC boxes to the MCC offices at 1440 Canal Street, and then Tony will be responsible for returning each box to its proper storage space.

On August 30, 1996, we received from the warehouse three boxes of documents that comprise all of the records that the temporary employee at the warehouse copied from the Metropolitan Crime Commission (MCC) files. As we agreed with the MCC, I returned copies of these documents for the MCC's records. Since the MCC still has control of all of the original records, I enclosed only the first page of documents that are three pages or longer. On the first page of these documents, I wrote the total number of pages, thus providing the MCC with a reliable record of those documents that we have here in Washington.

## Records in the Possession of Warren DeBrueys

Mr. DeBrueys met me at the offices of CBD Docusource and brought with him the nine boxes of MCC documents in his possession. When Jeremy and Phil looked at his boxes in June, they decided

that the Review Board would only be interested in copying documents from eight of the boxes. I went through the list that Jeremy and Phil created and tagged those documents for CBD Docusource to copy.

Mr. DeBrueys expressed concern about copying the Guy Banister boxes in their entirety for the JFK Collection. I offered to call back to the Review Board's offices to talk to Jeremy and/or Phil about his concerns, which are primarily that the MCC might be sued for any defamatory material that may be released if Guy Banister's materials become publicly available. I called Phil and Phil talked to Mr. DeBrueys about these concerns. Ultimately, Mr. DeBrueys agreed that he would allow us to copy the Guy Banister boxes in full. Phil can fill in the details of the terms of his agreement with DeBrueys, but I believe that Phil agreed to give Mr. DeBrueys an opportunity to review the material in the Banister boxes and propose redactions. In addition, I am fairly certain that Mr. DeBrueys believes that the Banister boxes have not yet been designated assassination records by the Review Board, and that the Board will consider his argument that Banister's police department files from the 1950s are not assassination records.

## Records Still in MCC Offices

Rafael Goyeneche and Tony Radosti were helpful in identifying those MCC "criminal organization" files that the HSCA reviewed. I told them that the Review Board would likely want to arrange to have those files copied for the JFK Collection. We discussed several options for copying the files. I told them that if the MCC would like to do the copying of those files itself, we would supply paper, folders, and shipping materials. In the alternative, I told them that we could probably arrange to have an outside copy company, like CBD Docusource, pick up the files to be copied from the MCC offices and then return those files once the copying is complete. I wrote to the MCC and asked them to let me know which option they would prefer. Once they let me know, we will arrange for the copying to start.

Tony told me that the MCC had at least two additional files folder on Guy Banister, but when we looked for them, they were not in the main filing system. He told me that he would look for these files, as he thought they were still somewhere in the office.

The HSCA reviewed some of the MCC's "criminal organization" files. I briefly looked at these files (listed below) and told Tony that we would want to copy them all.
