Subject: Addendum to Additional Request on General Edwin Walker, FBI-34

After comparing the "See" References listed in the supplemental correlation summary, document 116-165494-126, with the files previously provided by the FBI on General Edwin Walker, we decided to request 1 more file and 16 "See" References. The following represents those requests and subsequent review.

Section 1 9-41686-(1-8); December 23, 1963 - January 9, 1964

- All eight serials relate to a phone call received by General Walker accusing him of killing the President. The call was traced to Gerard Vincent who admitted placing the threatening call. Designate all eight serials as assassination records.

CR 100-354341-98; April 1, 1964

- Memo from Legat, Paris to Director, FBI regarding a French newspaper article on the assassination. Memo cross-referenced in 105-82555 and 62-109060.

CR 105-66233-1308; August 10, 1964

- Memo from Rosen to Belmont regarding the National States Rights Party and a recent article that Bobby Kennedy had his brother, President Kennedy assassinated. Original and copy filed in 62-109090 and 62-109060.
