Subject: Addendum to Summary of Minutemen Files, As Part of Request for Additional Information on General Edwin Walker (FBI-34)

I have completed review of the Minutemen Headquarters files. Sections 1-14, 16, 20-25, 35, 38-44, 46 had previously been on locate when I first submitted a summary of the Minutemen files. I have since reviewed these files and have summarized them below.

As of May 13, 1998, the FBI still has headquarters file 116-165494, section 3 of the General Edwin Walker file on locate.
