RE: ARRB Review of FBI Documents

Dear Terry:

In the communications between the ARRB and the FBI -- most recently in the May 11 meeting between ARRB staff members and the Bureau's JFK Task Force -- the FBI has described its current policies on certain postponement issues. We now understand that the FBI's present policies provide that:

- (a) information released in one record (or part of a record) will not be postponed elsewhere, unless there is a significant difference in context that would justify postponement;
- (b) the identities of persons who provided information to state or local law enforcement agencies will not be postponed under Sections 6(2) and (4) of the Act;
- (c) the symbol numbers of persons who were contacted but did not provide positive information to the FBI will not be postponed under Sections 6(2) and (4) of the Act; and
- (d) the identities of persons who gave the FBI information to which they had access by virtue of their employment will not be postponed under Sections 6(2) and (4) of the Act where their providing the information did not involve a breach of trust.

We recognize that applying these policies to some cases may involve relatively "close calls"; however, in many other cases these policies would suggest that some currently postponed documents should be released. In the course of reviewing FBI records, the ARRB staff has
