CIA COMPLIANCE -- BACKGROUND

A. CIA Records Currently in the JFK Collection

- Lee Harvey Oswald's 201 File (16 boxes) -- Has every document been released? Original file is in the JFK Collection, but where are the originals of any withheld/postponed documents? RIFs are not attached to the first 12 boxes.
- Microfilm Copy of the Oswald 201 File -- This is to be transferred to the JFK Collection in 2017. We should ask that it now be placed in the Protected Collection. Can CIA certify that this is a duplicate of the hard copy file? Can the CIA state when the file was microfilmed?
- CIA/HSCA "Sequestered Collection" (63 boxes) -- 153,000 pages released by 1995 [Is that everything?] Disks have not been turned over to NARA, but Review Board presumably has them.
- Box 64 of the Sequestered Collection -- 72 reels of microfilm. According to Martha Murphy, the documents printed from 71 reels of microfilm are open in the JFK Collection and consist of 80 archive boxes.
- Mexico City Station Folders provided to the Warren Commission -- Martha Murphy says that this is Boxes 41-43 of the Microfilm Sequestered Collection. Was there a separate submission?
- Minutes of DCI Morning Meetings (from 1963 to 1979) (400 pages) -- Martha Murphy confirms that this in the JFK Collection (under box 101).

- Oswald Security File No. 351164 (CIA-16) -- Confirm transfer to JFK Collection. In addition, there are documents re Oswald in an HTLINGUAL file and a defector file (CIA-IR-24).
