Subject: Subpoena of John Mohr Records

Several days ago, Dr. Richard Mohr identified for me over the phone the materials that he has so far collected in response to the subpoenas issued to him, Joseph Henry Scott and Mrs. Mohr. The materials are:

1. June 5, 1964 Brief of FBI Investigation of the Assassination (Blue Binder). Dr. Mohr indicated there were no notations made on this document.
2. May 6, 1964 Document entitled, "President's Commission on the Assassination of President Kennedy." Noted as copy 10 of 10.
3. December 13, 1963 Document re Investigation of the Assassination of President Kennedy (carbon copy).
4. Bound set of handwritten materials by Lee Harvey Oswald.
5. Investigation of the Assassination of John F. Kennedy, November 23, 1963 (Blue Binder) (January 13, 1964 Supplement).
6. Investigation of the Killing of Lee Harvey Oswald (Blue Binder).
7. Assassination of the President and the Killing of Lee Harvey Oswald -- Visual Aids (Blue Binders).

I today reviewed the FBI file on Edward Becker (HQ File No. 92-9927), which consists of 1967 memos that relate to Becker's allegation that Carlos Marcello threatened the life of President Kennedy in September 1962. In that file, the FBI wants to postpone the release of a source that discredits Becker, as well as postponing release of the identities of two other individuals providing information on Becker. Given the importance of Becker's allegation, I would suggest that our negotiating position be to require the FBI to provide additional information regarding the source, including, if necessary, the informant file.

In addition, the 1967 memos were prepared out of the Los Angeles field office, and we should ask to inspect the LA file that is referenced (File No. 92-2675) to determine if there is anything else on Becker not in the Headquarters file.

Subject: Cuban Revolutionary Junta

In May, I reviewed an FBI file on the Cuban Revolutionary Junta (HQ File No. 105-200064) and negotiated the file with the FBI. This file consists of a small volume of material covering the activities of JURE in Miami in the 1969-70 time period. The file is 20 pages or less.

The postponements in this file are for source names and numbers.

Subject: Junta Cubana Revolucionaria

In May, I reviewed an FBI file on the Junta Cubana Revolucionaria (Cuban Revolutionary Board) (HQ File No. 105-229101) and negotiated the file with the FBI. This file consists of one volume of material (100 pages or less) covering the activities of this anti-Castro group in 1972-74.

Almost all of the postponements pertain to source names and numbers. There were some postponements regarding substantive information provided by the source where the information could reasonably be expected to disclose the source, but these were kept to a minimum.
