Re: Forensic Examination of Original Notes of Frank Ragano

Dear Mr. Grasman:

Enclosed are several original notes of Frank Ragano which the Assassination Records Review Board ("Review Board") hereby requests be examined by the Forensic Services Division of the Secret Service to determine, to the extent possible, the date when these notes were made.

Allow me to provide some background for our request: Mr. Ragano is formerly an attorney from Tampa, Florida who has represented and known James Hoffa, Santo Trafficante, and Carlos Marcello, each of whom have been alleged to have some connection to the assassination of President Kennedy. In 1994, Mr. Ragano published his autobiography, entitled *Mob Lawyer*, in which he asserts that these individuals were complicit in the assassination of President Kennedy. We deposed Mr. Ragano earlier this month to determine whether he had contemporaneous notes of meetings he said involved discussions of President Kennedy's assassination. At his deposition, we asked Mr. Ragano when he made the notes. Although we do not have the transcript available yet, Mr. Ragano could not identify with specificity when he prepared the notes. Accordingly, Mr. Ragano has agreed to make available to the Review Board his original notes so that they could be examined further and, if possible, dated.

The notes concern meetings in 1963 and a conversation in 1987. To the extent that the Forensic Services Division can confirm or refute that these notes were made at about those dates, their analysis would be helpful. The Assassination Records Review Board is attempting to identify historical records that relate to the assassination of President Kennedy; to the extent that the enclosed notes are contemporaneous records of discussions that relate to the assassination, they would be of historical value and should be included in the JFK Collection; to the extent the notes were made after-the-fact in

conncetion with the writing of a book, they would be of little historical value and should not be included in the JFK Collection. Any help your Division can offer to resolve this issue would be appreciated and would benefit the public's interest in an accurate historical record.
