Dear Mr. Assistant Attorney General:

Pursuant to the President John F. Kennedy Assassination Records Collection Act of 1992, 44 U.S.C. § 2107, ("JFK Act"), the Assassinations Records Review Board ("Review Board") requests that the Department of Justice issue subpoenas duces tecum to:

Mr. Jerroll F. Custer 9920 Saltsburg Road Pittsburgh, Pennsylvania 15239

Edward F. Reed, Jr. 54 Blake Avenue Rockledge, Pennsylvania 19046

Messrs. Custer and Reed were employed by the U.S. Navy as x-ray technicians in November 1963. Both were involved in the autopsy of President Kennedy, and we believe they may possess important information with respect to the creation and identity of x-ray records relating to the autopsy of President Kennedy.

Both individuals have thus far refused to talk with the Review Board after repeated attempts by the

Review Board staff to interview them regarding the Kennedy autopsy.

We seek to subpoen the documents listed in Attachment A and schedule the depositions of Mr. Custer and Mr. Reed for October 22, 1997 at the National Archives and Records Administration ("NARA") in College Park, Maryland, where the Kennedy autopsy x-rays and photographs are located. We recognize that this would require Mr. Custer to travel over 200 miles from Pittsburgh and Mr. Custer to travel over 100 miles from the Philadelphia area; this is required in view of the fact that the autopsy records, which would be needed for the examinations, are located at NARA and cannot be removed. Nonetheless, the Review Board could, if necessary, conduct the depositions where the witnesses reside.
