Re: Production of Originals Records and Objects Prior to or at the
Deposition of Robert White

Dear Mr. Adler:

I am writing in response to the faxed letter that you sent on February 23 and the discussions that we had following our receipt of your letter. We also appreciate your client's having prepared the "Item Description: Assassination Related Items" that you attached to the February 23 letter. We believe that the lists you have now sent will help substantially in identifying the types of records that we are interested in examining. We further believe that Mr. White's willingness to acknowledge that he does have records that might qualify as assassination records will assist us in arriving at a speedier resolution of the issues.

We have agreed to reset the date of the deposition to Tuesday, March 3, 1998, at 9:30 in our offices. We anticipate that you will be bringing with you the original items that are responsive to our subpoena duces tecum, subject to the agreed limitations that we are continuing to discuss. You have expressed some concern about the Guernsey auction slated for March and the timing of the return to you of originals that may be a part of that auction. Although we cannot necessarily guarantee anything related to the status of records that we have not yet seen, I can advise that it is our current expectation that we will not need to retain possession of any of the original "Guernsey" items for more than a day or two. If you were to make these "Guernsey" items available for our inspection sometime this week, we would anticipate being able to return them to you by the time of the deposition next Tuesday.

I am identifying below the items on the inventories that we wish to examine and those that we currently see no need to examine. Our willingness to limit the scope of our requests is, however,

subject to two reservations.

First, if Mr. White possesses any additional assassination-related items that were not identified on the inventories, he must still produce them. These would include, of course, items that you identified in your letters to me (eg., Ruby's handwritten notes, file with notes re: JFK's trip to Dallas, etc.), as well as any other responsive documents. (We are also awaiting items 161 - 169 from the Guernsey's Consignment List. We requested these items in our February 2, 1998 letter. In your February 4, 1998 response letter, you stated that you would send us these additional items within the next several days. Please make sure to bring these items with you to Mr. White's deposition.)

Second, our determination *not* to request several of the items was based on the way that these particular items were described in the inventories. However, to the extent that any of the items you describe contain any relevant information regarding the assassination, those items should be produced.

For example, you identify several "first-day covers" that contain autographs. You do not need to produce these at the deposition unless -- by way of hypothetical example -- the "first-day covers" also include handwritten notes that discuss the assassination. Thus, to the extent that the descriptions are reasonably complete and do not omit important information, you do not need to produce the items as identified below.

I will identify the items we are requesting by referring to the item numbers in the inventories that you forwarded to us.

I. "Item Source: Evelyn & Harold Lincoln & Harold Lincoln Estate"
