In the event that any file has been destroyed, we request that all information pertaining to such destruction be provided. The results of these searches will be included in the Agency's Final

Compliance Statement.

We request that you make this information available to us by May 26, 1997. If this does not provide you with sufficient time, please let us know, in writing, by what date you believe you will be able to answer the query fully.

In requesting access to these materials, we are not designating them "assassination records" and we are not, at this time, requesting that copies be given to the Review Board.
