 - c. NSC delegation of declass authority to Archivist (is JFKL prepared to declass?)
 - d. CIA/State will start with NSF; ARRB will identify additional Cuba
- B. ARRB staff searching for additional ARs and EHUs¹
 - a. Rule of thumb: ARRB staff will review only records not open to public
 - b. ARRB is assuming that JFKL has identified ARs in open collections
 - c. Could JFKL send index to Presidential Recordings
- C. ARRB Review Procedures
 - a. Tracking sheet created for each box reviewed
 - b. Tracking sheet records only those files/documents identified for further processing
- D. Handling ARs (previously designated by JFKL)
