This letter constitutes our tenth formal request for additional information and records under the President John F. Kennedy Assassination Records Collection Act of 1992, 44 U.S.C. § 2107 (Supp. V 1994), (The "Act").

I am writing to request that you make available the files that were requested by the House Select Committee on Assassinations. A list of names of individuals whose files were requested appears in a letter from G. Robert Blakey to Robert Goff, March 1, 1978. [See HSCA-US Secret Service correspondence 180-10125-10002]. Because these records were requested by the House Select Committee on Assassinations, they are "assassination records" under the definition of the Act.
