Dear Mr. Chairman:

This letter is the Assassination Records Review Board's thirteenth and *final* monthly progress report, as required by the Committee on Government Reform and Oversight report on H.R. 1553 (now P.L. 105-25), which extended the authorization of the Review Board. The Review Board will cease operations on September 30, 1998.

The Review Board met on August 4-5 and August 25-26, 1998, and processed, through formal determinations and consent releases, approximately 6,250 documents. In the month of August, the Review Board acted on more than 2,000 FBI records, 1,630 CIA records, 1,280 INSCOM/CSF records, and approximately 1,340 records from other agencies.

This month our FBI team has negotiated the public release of XXXX pages of records from the FBI's HSCA subject files. This number is lower that previous months, however that is due to the fact that our review of FBI records is near completion. We are also finalizing our review of records produced by the FBI in response to our requests for additional information.

The Review Board continues to process CIA records at an accelerated pace. At our July meetings, the Review Board processed more than 1,600 CIA records. The documents continue to flow from CIA, and we have strong indications that we will complete the review of CIA materials by the end of September. In addition, the CIA recently transferred to the JFK Collection the original of a multi-volume Office of Security file that it had maintained on Lee Harvey Oswald.

The Board processed more than 200 Army and Joint Chiefs of Staff (JCS) documents this month. Also, more than 200 additional Army and JCS records from the papers of Joseph A. Califano, Jr. were transferred to the JFK Collection last week. I am happy to report that we recently received permission form the Senate Select Committee on Intelligence to inspect the original Church Committee files. The Review Board plans to begin this review beginning August 3 to ensure that all relevant Church Committee materials have been identified under the JFK Act. Although the originals were inspected by staff members of the Senate Intelligence Committee several years ago to identify materials to be released under the JFK Act, no member of the Review Board or the National Archives has had access to inspect the originals. Additionally, last week we transferred to the JFK Collection additional transcripts of witnesses who testified before the Church Committee, including former Secretary of Defense Robert McNamara and former DCI Richard Helms. We have met with the CIA, and have memorialized in a letter to the General Counsel of CIA, the outstanding items to be completed by the CIA under the JFK Act before September 30. At the Review Board's request, CIA Director George Tenet has issued a CIA-wide directive requesting that a final check be done for any records relating to Oswald or the assassination.

As reported in our letter last month, we are unfortunately still working with the House Judiciary Committee to obtain access to inspect certain HUAC [House on Un-American Activities] records.

Finally, we have had some significant staff changes that I would like to report. Our Executive Director, Jeremy Gunn, has moved on to the U.S. Institute of Peace. We are grateful for his hard work and dedication to the Review Board these last four years, and we regret his departure. I am pleased, however, to inform you that the Board has named Laura Denk, the Review Board's FBI Team Leader, as our new Executive Director. Tracy Shycoff, Associate Director For Administration, has been named our Deputy Director, and Ron Haron, who served as our Associate General Counsel, is now our General Counsel. We are confident that our efforts will continue as scheduled and we look forward to fulfilling our mandate by September 30, 1998.

1. <u>Deposition of Dallas Doctors</u> -- The Review Board conducted, in Dallas, a joint deposition of five of the Parkland Hospital personnel who treated President Kennedy on November 22, 1963.

2. <u>Review of Church Committee Records</u> -- The Review Board staff, in early August, completed review of all original Church Committee files, which were available through the cooperation of the Senate Intelligence Committee. The staff identified additional records to be processed under the JFK Act.

3. <u>Sixth Floor Museum</u> -- We have concluded an agreement with the Sixth Floor Museum in Dallas to obtain, for the JFK Collection, copies of certain records, including Parkland Hospital records and home movies taken in Dallas on the day of the assassination.

4. <u>JFK Library</u> -- On August 26, the JFK Library briefed the members of the Review Board regarding the completion of the Library's work under the JFK Act.

5. <u>PFIAB</u> -- On August 25, the Charirman of the President's Foreign Intelligence Advisory Board ("PFIAB"), Senator Warren Rudman, appeared before the members of the Review Board to present PFIAB's position that the PFIAB records identified by the Review Board are not subject to the JFK Act. The Review Board, after considering PFIAB's views, proceeded to formally designate these PFIAB records as assassination records within the meaning of the JFK Act.

6. <u>HUAC</u> -- The Review Board has attempted to secure permission from the House Judiciary Committee to inspect certain records of the House Committee on Un-American Activities ("HUAC") that Review Board has reason to believe may qualify as assassination records within the coverage of the JFK Act. To date, these records have not been made available for inspection by the Review Board and, at present, will not be released to the public even though they include files on Lee Harevey Oswald and Marina Oswald.

7. <u>Congressional Research Service</u> -- The Congressional Research Service has identified certain records, mostly memoranda prepared for the House Select Committee on Assassinations, as assassination records under the JFK Act. CRS has received the appropriate Congressional authorization to release these records, and they will be transmitted to the JFK Collection.

8. <u>Final Declarations of Compliance</u> -- The Review Board is continuing to receive Final Declarations of Compliance from various agencies certifying their compliance with the JFK Act. Most recently, the Review Board has received Final Declarations from the FBI, the CIA [Eileen -- we expect to receive this today, 9/2], the NSA, the Department of Treasury, the JFK Library, the LBJ

Library, the Ford Library, the Civil Division of the Department of Justice, the Leadership Offices for the Department of Justice, and the Immigration & Naturalization Service.
