DEED OF GIFT FOR RECORDS IN THE POSSESSION OF THE SIXTH FLOOR MUSEUM

1. In accordance with the provisions of chapter 21 of title 44, United States Code, and subject to the terms, conditions, and restrictions set forth in this instrument, the Sixth Floor Museum, through its representative Mr. Michael H. Collins (the "Donor") gives, donates, and conveys to the Untied States of America, for deposit in the President John F. Kennedy Assassinations Records Collection (the "JFK Collection") at the National Archives and Records Administration ("NARA"), the following historical materials (hereinafter referred to as "the Donated Materials"):

Archival quality copies of the following record collections and films in the possession of the Sixth Floor Museum:

Parkland Hospital records, including treatment records for President Kennedy; autopsy records for Oswald, Ruby, and Tippit; and medical records for Ruby (identified under Museum inventory no. 1994.001);

Dallas County District Court papers regarding the Ruby case (identified under inventory no. 1994.002);

Papers of Dr. Charles J. Carrico (identified under inventory no. 1997.044);

Papers of William A. McKenzie relating to his representation of Robert and Marina Oswald before the Warren Commission (identified under inventory no. 1997.047);

The Dorman film taken from the Texas School Book Depository and showing part of the Presidential motorcade, but not the assassination;

The Bronson film showing the Presidential motorcade, including part of the assassination;

The Couch film, which shows the Kennedy's arrival at Love Field, events outside Parkland Hospital while the crowd awaited word of the President's condition, an interview of Jack Ruby, and a flyover of the motorcade route; and

The Sanders film, which shows part of the Presidential motorcade.

- 2. The Donor warrants that, at the time of the execution of this Deed of Gift, he possesses title to, and all rights and interest in, the Donated Materials, free and clear of all liens, claims, charges, or encumbrances, and that he has the authority to covney the Donated Materials to NARA.
- 3. Upon executing this Deed of Gift, the Donor will transfer the Donated Materials to NARA through the Assassination Records Review Board ("the Review Board"). The Donated Materials will be placed in the JFK Collection in accordance with the JFK Act.
- 4. Title to the Donated Materials shall pass to the United States upon final execution of this Deed of Gift by the Donor, the Review Board, and NARA.
- 5. The United States shall have the right to make and distribute copies of the Donated Materials.
- 6. NARA may, subject only to restrictions placed upon it by law or regulation, provide for the preservation, arrangement, repair and rehabilitation, duplication and reproduction, description, exhibition, display, and servicing of the Donated Materials as may be needful or appropriate.
